# ANALYSIS OF BOUNDARY-DOMAIN INTEGRAL EQUATIONS TO THE MIXED BVP FOR A COMPRESSIBLE STOKES SYSTEM WITH VARIABLE VISCOSITY

ABSTRACT. The mixed boundary value problem for a compressible Stokes system of partial differential equations in a bounded domain is reduced to two different systems of segregated direct Boundary-Domain Integral Equations (BDIEs) expressed in terms of surface and volume parametrix-based potential type operators. Equivalence of the BDIE systems to the mixed BVP and invertibility of the matrix operators associated with the BDIE systems are proved in appropriate Sobolev spaces.

1. Introduction. Boundary integral equations and the hydrodynamic potential theory for the Stokes PDE system with constant viscosity have been extensively studied in numerous publications, cf., e.g., [10, 12, 8, 24, 28, 9, 31]. The reduction of different boundary value problems for the Stokes system to boundary integral equations in the case of constant viscosity was possible since the fundamental solutions for both, velocity and pressure, are readily available in an explicit form. Such reduction was used not only to analyse the properties of the Stokes system and BVP solutions, but also to solve BVPs by solving numerically the corresponding boundary integral equations.

In this paper we consider the stationary Stokes PDE system with variable viscosity and compressibility, in a bounded domain that models the motion of a laminar compressible viscous fluid, e.g., through a variable temperature field that makes both, viscosity and compressibility depending on coordinates. Reduction of the BVPs for the Stokes system with arbitrarily variable viscosity to explicit boundary integral equations is usually not possible, since the fundamental solution needed for such reduction is generally not available in an analytical form (except for some special dependence of the viscosity on coordinates). Using a *parametrix* (*Levi function*) as a substitute of a fundamental solution, in the spirit of [11], [7], it is possible

however to reduce such BVPs to some systems of Boundary-Domain Integral Equations, BDIEs, (cf. e.g. [21, Sect. 18], [23, 22], where the Dirichlet, Neumann and Robin problems for some PDEs were reduced to *indirect* BDIEs).

We will extend here the approach developed in [1, 16] for a scalar variablecoefficient PDE, and will reduce the mixed boundary value problem for a *compressible* Stokes system of partial differential equations to two different systems of segregated direct BDIEs expressed in terms of surface and volume parametrixbased potential type operators. A parametrix for a given PDE (or PDE system) is not unique and a special care will be taken to chose a parametrix that leads to the BDIE systems simple enough to be analysed. The mapping properties of the parametrix-based hydrodynamic surface and volume potentials will be obtained and the equivalence and invertibility theorems for the operators associated with the BDIE systems will be proved.

Some preliminary results in this direction were obtained in [19], where we derived BDIE systems for the mixed *incompressible* Stokes problem in a bounded domain and equivalence between the BVP and BDIE systems was shown, however, invertibility results were not given there.

Note that the paper is mainly aimed not at the mixed boundary-value problem for the Stokes system, which properties are well-known nowadays, but rather at analysis of the BDIE systems per se. The analysis is interesting not only in its own rights but is also to pave the way for studying the corresponding localised BDIEs and analysing convergence and stability of BDIE-based numerical methods for PDEs, cf., e.g., [16, 2, 6, 18, 17, 26, 27, 29, 32, 33].

2. **Preliminaries.** Let  $\Omega = \Omega^+ \subset \mathbb{R}^3$  be a *bounded* and simply-connected domain and let  $\Omega^- := \mathbb{R}^3 \setminus \overline{\Omega}^+$ . We will assume that the boundary  $\partial \Omega$  is simply connected, closed and infinitely differentiable. Furthermore,  $\partial \Omega := \overline{\partial \Omega}_N \cup \overline{\partial \Omega}_D$  where both  $\partial \Omega_N$  and  $\partial \Omega_D$  are non-empty, connected disjoint submanifolds of  $\partial \Omega$ . The interface between these two submanifolds is also infinitely differentiable.  $\partial \Omega_N = \partial \Omega_D \in \mathcal{C}^{\infty}$ . CHECK.

Let  $\boldsymbol{v}$  be the velocity vector field; p the pressure scalar field and  $\mu \in \mathcal{C}^{\infty}(\Omega)$  be the variable kinematic viscosity of the fluid such that  $\mu(\boldsymbol{x}) > c > 0$ .

For an arbitrary couple (p, v) the stress tensor operator,  $\sigma_{ij}$ , and the Stokes operator,  $\mathcal{A}_j$ , for a compressible fluid are defined as

$$\sigma_{ji}(p, \boldsymbol{v})(\boldsymbol{x}) := -\delta_i^j p(\boldsymbol{x}) + \mu(\boldsymbol{x}) \left( \frac{\partial v_i(\boldsymbol{x})}{\partial x_j} + \frac{\partial v_j(\boldsymbol{x})}{\partial x_i} - \frac{2}{3} \delta_i^j \operatorname{div} \boldsymbol{v}(\boldsymbol{x}) \right),$$

$$\mathcal{A}_{j}(p,\boldsymbol{v})(\boldsymbol{x}) := \frac{\partial}{\partial x_{i}} \sigma_{ji}(p,\boldsymbol{v})(\boldsymbol{x}) = \frac{\partial}{\partial x_{i}} \left( \mu(\boldsymbol{x}) \left( \frac{\partial v_{j}(\boldsymbol{x})}{\partial x_{i}} + \frac{\partial v_{i}(\boldsymbol{x})}{\partial x_{j}} - \frac{2}{3} \delta_{i}^{j} \operatorname{div} \boldsymbol{v}(\boldsymbol{x}) \right) \right) - \frac{\partial p(\boldsymbol{x})}{\partial x_{j}}, \quad j, i \in \{1, 2, 3\}, \quad (2.2)$$

where  $\delta_i^j$  is the Kronecker symbol. Henceforth we assume the Einstein summation in repeated indices from 1 to 3 if not stated otherwise.

We denote the Stokes operator as  $\mathcal{A} = \{\mathcal{A}_j\}_{j=1}^3$  and  $\mathcal{A} := \mathcal{A}|_{\mu=1}$ . We will also use the following notation for derivative operators:  $\partial_j = \partial_{x_j} := \frac{\partial}{\partial x_j}$  with  $j = 1, 2, 3; \nabla := (\partial_1, \partial_2, \partial_3)$ . In what follows,  $\mathcal{D}(\Omega)$  is the space of infinitely smooth functions with a compact support on  $\Omega$ ,  $H^s(\Omega)$ ,  $H^s(\partial\Omega)$  are the Bessel potential spaces, where  $s \in \mathbb{R}$  is an arbitrary real number (see, e.g., [12, 13]). We recall that  $H^s$  coincide with the Sobolev–Slobodetski spaces  $W_2^s$  for any non-negative s. Let  $H_K^s := \{g \in H^1(\mathbb{R}^3) : \operatorname{supp}(g) \subseteq K\}$  where K is a compact subset of  $\mathbb{R}^3$ . We will also use the bold notation like  $H^s(\Omega) = [H^s(\Omega)]^3$ , for 3-dimensional vector function spaces. We denote by  $\widetilde{H}^s(\Omega)$  the subspace of  $H^s(\mathbb{R}^3), \widetilde{H}^s(\Omega) := \{g : g \in$  $H^s(\mathbb{R}^3)$ ,  $\operatorname{supp} g \subset \overline{\Omega}\}$  and similarly,  $\widetilde{H}^s(S_1) := \{g \in H^s(\partial\Omega), \operatorname{supp} g \subset \overline{S}_1\}$ . We will also make use of the following space (cf. e.g. [3, 1]),

$$\boldsymbol{H}^{s,0}(\Omega;\boldsymbol{\mathcal{A}}) := \{(p,\boldsymbol{v}) \in H^{s-1}(\Omega) \times \boldsymbol{H}^{s}(\Omega) : \boldsymbol{\mathcal{A}}(p,\boldsymbol{v}) \in \boldsymbol{L}_{2}(\Omega)\},$$

endowed with the norm

$$\|(p,\boldsymbol{v})\|_{\boldsymbol{H}^{s,0}(\Omega;\boldsymbol{\mathcal{A}})} := \left(\|p\|_{H^{s-1}(\Omega)}^2 + \|\boldsymbol{v}\|_{\boldsymbol{H}^s(\Omega)}^2 + \|\boldsymbol{\mathcal{A}}(p,\boldsymbol{v})\|_{\boldsymbol{L}_2(\Omega)}^2\right)^{1/2}.$$

**Remark 2.1.** Note that  $\boldsymbol{H}^{s,0}(\Omega; \boldsymbol{\mathcal{A}}) = \boldsymbol{H}^{s,0}(\Omega; \boldsymbol{\mathcal{A}})$  with equivalent norms, if  $s \geq 1$ . Note as well that this equality should be understood as an algebraic equality of the function spaces with equivalent norms. Indeed,  $\mathcal{A}_j(p, \boldsymbol{v}) = \mu \mathcal{A}_j(p, \boldsymbol{v}) + B_j(p, \boldsymbol{v})$ , where

$$B_j(p, \boldsymbol{v}) := \frac{\partial \mu(\boldsymbol{x})}{\partial x_i} \left( \frac{\partial v_j(\boldsymbol{x})}{\partial x_i} + \frac{\partial v_i(\boldsymbol{x})}{\partial x_j} - \frac{2}{3} \delta_i^j \operatorname{div} \boldsymbol{v}(\boldsymbol{x}) \right) \in \boldsymbol{L}_2(\Omega)$$

if  $\boldsymbol{v} \in \boldsymbol{H}^{s}(\Omega)$  and  $s \geq 1$ .

Similar to [15, Theorem 3.12] one can prove the following assertion.

**Theorem 2.2.** The space  $\mathcal{D}(\overline{\Omega}) \times \mathcal{D}(\overline{\Omega})$  is dense in  $H^{1,0}(\Omega; \mathcal{A})$ .

The operator  $\mathcal{A}$  acting on (p, v) is well defined in the weak sense provided  $\mu(x) \in L^{\infty}(\Omega)$  as

$$\langle \mathcal{A}(p, \boldsymbol{v}), \boldsymbol{u} \rangle_{\Omega} := -\mathcal{E}((p, \boldsymbol{v}), \boldsymbol{u}), \qquad \forall \boldsymbol{u} \in \widetilde{\boldsymbol{H}}^{1}(\Omega),$$

where the form  $\mathcal{E}: [L^2(\Omega) \times H^1(\Omega)] \times \widetilde{H}^1(\Omega) \to \mathbb{R}$  is defined as

$$\mathcal{E}\left((p,\boldsymbol{v}),\boldsymbol{u}\right) := \int_{\Omega} E\left((p,\boldsymbol{v}),\boldsymbol{u}\right)(\boldsymbol{x}) \, d\boldsymbol{x},\tag{2.4}$$

and the function E((p, v), u) is defined as

$$E((p, \boldsymbol{v}), \boldsymbol{u})(\boldsymbol{x}) := \frac{1}{2} \mu(\boldsymbol{x}) \left( \frac{\partial u_i(\boldsymbol{x})}{\partial x_j} + \frac{\partial u_j(\boldsymbol{x})}{\partial x_i} \right) \left( \frac{\partial v_i(\boldsymbol{x})}{\partial x_j} + \frac{\partial v_j(\boldsymbol{x})}{\partial x_i} \right) - \frac{2}{3} \mu(\boldsymbol{x}) \operatorname{div} \boldsymbol{v}(\boldsymbol{x}) \operatorname{div} \boldsymbol{u}(\boldsymbol{x}) - p(\boldsymbol{x}) \operatorname{div} \boldsymbol{u}(\boldsymbol{x}).$$

For sufficiently smooth functions  $(p, v) \in H^{s-1}(\Omega^{\pm}) \times H^s(\Omega^{\pm})$  with s > 3/2, we can define the classical traction operators,  $T^{c\pm} = \{T_i^{c\pm}\}_{i=1}^3$ , on the boundary  $\partial\Omega$  as

$$T_{i}^{c\pm}(p,\boldsymbol{v})(\boldsymbol{x}) := [\gamma^{\pm}\sigma_{ij}(p,\boldsymbol{v})(\boldsymbol{x})]n_{j}(\boldsymbol{x})$$
  
$$= -n_{i}(\boldsymbol{x})\gamma^{\pm}p(\boldsymbol{x}) + n_{j}(\boldsymbol{x})\mu(\boldsymbol{x})\gamma^{\pm} \left(\frac{\partial v_{i}(\boldsymbol{x})}{\partial x_{j}} + \frac{\partial v_{j}(\boldsymbol{x})}{\partial x_{i}} - \frac{2}{3}\delta_{i}^{j}\operatorname{div}\boldsymbol{v}(\boldsymbol{x})\right), \ \boldsymbol{x} \in \partial\Omega,$$

where  $n_j(\boldsymbol{x})$  denote components of the unit outward normal vector  $\boldsymbol{n}(\boldsymbol{x})$  to the boundary  $\partial \Omega$  of the domain  $\Omega$  and  $\gamma^{\pm}(\cdot)$  denote the trace operators from inside and outside  $\Omega$ . We will sometimes write  $\gamma u$  if  $\gamma u^+ = \gamma u^-$ , and similarly for  $\boldsymbol{T}^c$ , etc.

Traction operators (2.6) can be continuously extended to the *canonical* traction operators  $T^{\pm}: H^{1,0}(\Omega^{\pm}; \mathcal{A}) \to H^{-1/2}(\partial\Omega)$  defined in the weak form [19, Section 34.1] similar to [3, Lemma 3.2], [15, Definition 3.8], [5, Definition 2.10] as

Here the operator  $\gamma^{-1}: H^{1/2}(\partial\Omega) \to H^1(\mathbb{R}^3)$  denotes a continuous right inverse of the trace operator  $\gamma: H^1(\mathbb{R}^3) \to H^{1/2}(\partial\Omega)$ .

Furthermore, if  $(p, v) \in H^{1,0}(\Omega; \mathcal{A})$  and  $u \in H^1(\Omega)$ , the following first Green identity holds, [19, Eq. (34.2)], cf. also [3, Lemma 3.4(i)], [15, Theorem 3.9], [5, Lemma 2.11]

$$\langle \mathbf{T}^{+}(p, \boldsymbol{v}), \boldsymbol{\gamma}^{+}\boldsymbol{u} \rangle_{\partial\Omega} = \int_{\Omega} [\boldsymbol{\mathcal{A}}(p, \boldsymbol{v})\boldsymbol{u} + E((p, \boldsymbol{v}), \boldsymbol{u})(\boldsymbol{x})] dx.$$

Applying identity (2.7) to the pairs  $(p, v), (q, u) \in H^{1,0}(\Omega; \mathcal{A})$  with exchanged roles and subtracting the one from the other, we arrive at the second Green identity, cf. [3, Lemma 3.4(ii)], [15, Eq. 4.8], [5, Lemma 2.11],

$$\int_{\Omega} \left[ \mathcal{A}_{j}(p, \boldsymbol{v}) u_{j} - \mathcal{A}_{j}(q, \boldsymbol{u}) v_{j} + q \operatorname{div} \boldsymbol{v} - p \operatorname{div} \boldsymbol{u} \right] dx$$
$$= \langle \boldsymbol{T}^{+}(p, \boldsymbol{v}), \boldsymbol{\gamma}^{+} \boldsymbol{u} \rangle_{\partial \Omega} - \langle \boldsymbol{T}^{+}(q, \boldsymbol{u}), \boldsymbol{\gamma}^{+} \boldsymbol{v} \rangle_{\partial \Omega}.$$

Now we are ready to formulate the following mixed BVP for which we aim to derive equivalent BDIE systems and investigate the existence and uniqueness of their solutions.

Given  $\boldsymbol{f} \in \boldsymbol{L}_2(\Omega)$ ,  $g \in L^2(\Omega)$ ,  $\boldsymbol{\varphi}_0 \in \boldsymbol{H}^{1/2}(\partial \Omega_D)$  and  $\boldsymbol{\psi}_0 \in \boldsymbol{H}^{-1/2}(\partial \Omega_N)$ , find  $(p, \boldsymbol{v}) \in \boldsymbol{H}^{1,0}(\Omega, \boldsymbol{\mathcal{A}})$  such that:

$$\mathcal{A}(p, \boldsymbol{v})(\boldsymbol{x}) = \boldsymbol{f}(\boldsymbol{x}), \ \boldsymbol{x} \in \Omega,$$

$$\operatorname{div} \boldsymbol{v}(\boldsymbol{x}) = g(\boldsymbol{x}), \ \boldsymbol{x} \in \Omega, \tag{2.9b}$$

$$r_{\partial\Omega_N} \boldsymbol{T}^+(\boldsymbol{p}, \boldsymbol{v})(\boldsymbol{x}) = \boldsymbol{\psi}_0(\boldsymbol{x}), \ \boldsymbol{x} \in \partial\Omega_N.$$

Applying the first Green identity, it is easy to prove the following uniqueness result.

### **Theorem 2.3.** Mixed BVP (2.9) has at most one solution in the space $H^{1,0}(\Omega; \mathcal{A})$ .

*Proof.* Let us suppose that there are two possible solutions:  $(p_1, \boldsymbol{v}_1)$  and  $(p_2, \boldsymbol{v}_2)$  belonging to the space  $\boldsymbol{H}^{1,0}(\Omega; \boldsymbol{\mathcal{A}})$ , that satisfy the BVP (2.9). Then, the pair  $(p, \boldsymbol{v}) := (p_2, \boldsymbol{v}_2) - (p_1, \boldsymbol{v}_1)$  also belongs to the space  $\boldsymbol{H}^{1,0}(\Omega; \boldsymbol{\mathcal{A}})$  and satisfies the following homogeneous mixed BVP

$$\mathcal{A}(p, \boldsymbol{v})(\boldsymbol{x}) = \boldsymbol{0}, \ \boldsymbol{x} \in \Omega,$$
(2.10a)

$$\operatorname{div}(\boldsymbol{v})(\boldsymbol{x}) = 0, \ \boldsymbol{x} \in \Omega, \tag{2.10b}$$

$$r_{\partial\Omega_D} \boldsymbol{\gamma}^+ \boldsymbol{v}(\boldsymbol{x}) = \boldsymbol{0}, \ \boldsymbol{x} \in \partial\Omega_D, \tag{2.10c}$$

$$r_{\partial\Omega_N} T^+(p, v)(x) = 0, \ x \in \partial\Omega_N.$$

Applying the first Green identity (2.7) to (p, v) and u = v and taking into account (2.10), we obtain,

$$\int_{\Omega} \frac{1}{2} \mu(\boldsymbol{x}) \left( \frac{\partial v_i(\boldsymbol{x})}{\partial x_j} + \frac{\partial v_j(\boldsymbol{x})}{\partial x_i} \right)^2 dx = 0.$$

As  $\mu(\boldsymbol{x}) > 0$ , the only possibility is that  $\boldsymbol{v}(\boldsymbol{x}) = \boldsymbol{a} + \boldsymbol{b} \times \boldsymbol{x}$ , i.e.,  $\boldsymbol{v}$  is a rigid motion, [13, Lemma 10.5]. Nevertheless, taking into account the Dirichlet condition (2.10c), we deduce that  $\boldsymbol{v} \equiv \boldsymbol{0}$ . Hence,  $\boldsymbol{v}_1 = \boldsymbol{v}_2$ .

Considering now  $v \equiv 0$  and keeping in mind the Neumann-traction condition (2.10d), it is easy to conclude that  $p_1 = p_2$ .

3. **Parametrix and remainder.** When  $\mu(\boldsymbol{x}) = 1$ , the operator  $\boldsymbol{\mathcal{A}}$  becomes the constant-coefficient Stokes operator  $\boldsymbol{\mathcal{A}}$ , for which we know an explicit fundamental solution defined by the pair of functions  $(\mathring{q}^k, \mathring{\boldsymbol{u}}^k)$ , where summation in k is not assumed,  $\mathring{u}_j^k$  represent components of the incompressible velocity fundamental solution and  $\mathring{q}^k$  represent the components of the pressure fundamental solution (see e.g. [10, 9, 8]).

$$\mathring{q}^{k}(\boldsymbol{x},\boldsymbol{y}) = -\frac{(x_{k} - y_{k})}{4\pi|\boldsymbol{x} - \boldsymbol{y}|^{3}} = \frac{\partial}{\partial x_{k}} \left(\frac{1}{4\pi|\boldsymbol{x} - \boldsymbol{y}|}\right),$$
(3.1)

$$\mathring{u}_{j}^{k}(\boldsymbol{x},\boldsymbol{y}) = -\frac{1}{8\pi} \left\{ \frac{\delta_{j}^{k}}{|\boldsymbol{x}-\boldsymbol{y}|} + \frac{(x_{j}-y_{j})(x_{k}-y_{k})}{|\boldsymbol{x}-\boldsymbol{y}|^{3}} \right\}, \quad j,k \in \{1,2,3\}.$$

Therefore, the couple  $(\mathring{q}^k, \mathring{\boldsymbol{u}}^k)$  satisfies

$$\frac{\partial}{\partial x_k} \mathring{q}^k(\boldsymbol{x}, \boldsymbol{y}) = \sum_{i=1}^3 \frac{\partial^2}{\partial x_k^2} \left( \frac{1}{4\pi |\boldsymbol{x} - \boldsymbol{y}|} \right) = -\delta(\boldsymbol{x} - \boldsymbol{y}), \quad (3.3)$$

Here and henceforth,  $\delta(\cdot)$  is Dirac's distribution.

Let us denote  $\mathring{\sigma}_{ij}(p, \boldsymbol{v}) := \sigma_{ij}(p, \boldsymbol{v})|_{\mu=1}, \mathring{T}_i^c(p, \boldsymbol{v}) := T_i^c(p, \boldsymbol{v})|_{\mu=1}$ . Then by (2.1) the stress tensor of the fundamental solution reads as

No summation in k is assumed in (3.8)-(3.9).

is a weakly singular remainder and no summation in k is assumed in (3.10)-(3.11). This implies that  $(q^k, u^k)$  is a parametrix of the operator  $\mathcal{A}$ . Let us keep in mind that we have not assumed summation on the index k in (3.8)-(3.11).

Note that the parametrix is generally not unique (cf. [20] for BDIEs based on an alternative parametrix for a scalar PDE). The possibility to factor out  $\frac{\mu(\boldsymbol{x})}{\mu(\boldsymbol{y})}$  in (3.8)-(3.9) and  $\frac{\nabla \mu(\boldsymbol{x})}{\mu(\boldsymbol{y})}$  in (3.11) is due to the careful choice of the parametrix in form (3.6)-(3.7) and this essentially simplifies the analysis of obtained parametrix-based potentials and BDIE systems further on.

4. Parametrix-based volume and surface potentials. Let  $\rho$  and  $\rho$  be sufficiently smooth scalar and vector functions on  $\overline{\Omega}$ , e.g.,  $\rho \in \mathcal{D}(\overline{\Omega})$ ,  $\rho \in \mathcal{D}(\overline{\Omega})$ . Let us define the parametrix-based Newton-type and remainder vector potentials for the velocity,

of distribution, and the equality between (4.3) and (4.4) holds since

Note that although the constant-coefficient velocity potentials  $\mathcal{U}\rho$ ,  $\mathcal{V}\rho$  and  $\mathcal{W}\rho$ are divergence-free in  $\Omega^{\pm}$ , the corresponding potentials  $\mathcal{U}\rho$ ,  $V\rho$  and  $W\rho$  are not divergence-free for the variable coefficient  $\mu(\mathbf{y})$ . *Proof.* Since the surface  $\partial\Omega$  is infinitely differentiable, the operators  $\mathcal{U}$  and  $\mathcal{Q}$  are respectively pseudodifferential operators of order -2 and -1, see, e.g., [8, Lemma 5.6.6. and Section 9.1.3]. Then, the continuity of the operators  $\mathcal{U}$  and  $\mathcal{Q}$  from the 'tilde spaces', i.e., (4.18) and (4.20), immediately follows by virtue of the mapping properties of the pseudodifferential operators (see, e.g. [4, 14]). Alternatively, these mapping properties are well studied for the constant coefficient case, i.e. operators  $\mathcal{U}$  and  $\hat{\mathcal{Q}}$ , see [8, Lemma 5.6.6]. Then continuity of operator (4.22) immediately

follows from representation (4.2) and continuity of operator (4.20). Continuity of the remainder operators (4.24) and (4.26) is also implied by continuity of operators (4.20), (4.18) and relations (4.7), (4.9).

Furthermore, using representation (4.31) one can prove by induction that the operator (4.19) is continuous also for  $s \in (k - 1/2, k + 1/2), k \in \mathbb{N}$ . Continuity of the operator (4.19) for the cases s = k + 1/2 is proved by applying the theory of interpolation of Bessel potential spaces (see, e.g. [30, Chapter 4]).

The continuity of operator (4.21) and hence (4.23) can be proved following a similar argument. The continuity of remainder operators (4.25) and (4.27) immediately follows from the continuity of operators (4.19) and (4.21) by relations (4.7) and (4.9). The continuity of operators (4.28) and (4.30) is implied by the continuity of operators (4.19), (4.23) and (4.25), (4.27), respectively, along with the space definition (2.3).

Let us prove continuity of operator (4.29). Let  $\rho \in H^{s-1}(\Omega)$  and  $g = \mu\rho$ . Then by relation (4.8) and mapping property (4.21),  $(\frac{4}{3}\mu\rho, \mathbf{Q}\rho) = (\frac{4}{3}g, \frac{1}{\mu}\mathbf{\mathring{Q}}g) \in H^{s-1}(\Omega) \times \mathbf{H}^{s}(\Omega)$  and

By (4.17),  $\mathring{A}_{j}(\frac{4}{3}g, -\mathring{Q}g) = 0$ , while

is a continuous operator due to (4.21), which implies continuity of (4.29).

*Proof.* The proof of the compactness for the operators  $\mathcal{R}$ ,  $\gamma^+ \mathcal{R}$  and  $\mathcal{R}^{\bullet}$  immediately follows from Theorem 4.1 and the trace theorem along with the Rellich compact embedding theorem.

To prove compactness of the operators  $T^{\pm}(\mathcal{R}^{\bullet}, \mathcal{R})$ , let us consider a function  $g \in H^1(\Omega)$ . Then,  $(\mathcal{R}^{\bullet}g, \mathcal{R}g) \in H^1(\Omega) \times H^2(\Omega) \subset H^{1,0}(\Omega; \mathcal{A})$ , which implies that both canonical and classical conormal derivatives of  $(\mathcal{R}^{\bullet}g, \mathcal{R}g)$  are well defined and moreover, similar to [15, Corollary 3.14] and [5, Theorem 2.13], one can prove that they coincide,  $T^{\pm}(\mathcal{R}^{\bullet}g, \mathcal{R}g) = T^{c\pm}(\mathcal{R}^{\bullet}g, \mathcal{R}g) \in H^{1/2}(\partial\Omega)$ . By definitions (2.1), (2.6), the operators  $T^{c\pm} : H^1(\Omega) \times H^2(\Omega) \to H^{1/2}(\partial\Omega)$  are continuous, which implies that the operators  $T^{\pm}(\mathcal{R}^{\bullet}, \mathcal{R}) = T^{c\pm}(\mathcal{R}^{\bullet}, \mathcal{R}) : H^1(\Omega) \to H^{1/2}(\partial\Omega)$  are continuous as well. Then, compactness of the operators  $T^{\pm}(\mathcal{R}^{\bullet}, \mathcal{R}) = T^{c\pm}(\mathcal{R}^{\bullet}, \mathcal{R}) : H^1(\Omega) \to H^{-1/2}(\partial\Omega)$  follows from the Rellich compact embedding  $H^{1/2}(\partial\Omega) \hookrightarrow H^{-1/2}(\partial\Omega)$ .

*Proof.* The continuity of the operators in (4.33), (4.34) follows from relations (4.10), (4.11) and the continuity of the counterpart operators for the constant coefficient case, see e.g. [9, 8].

Let us prove continuity of the operators in (4.35). We first remark that an arbitrary pair  $(p, \boldsymbol{v})$  belongs to  $\boldsymbol{H}^{1,0}(\Omega; \boldsymbol{\mathcal{A}})$  if  $(p, \boldsymbol{v}) \in L^2(\Omega) \times \boldsymbol{H}^1(\Omega)$  and  $\boldsymbol{\mathcal{A}}(p, \boldsymbol{v}) \in L^2(\Omega)$ . First, let us prove the corresponding mapping property for the pair  $(\Pi^s, \mathbf{V})$ . Let  $\mathbf{\Psi} \in \mathbf{H}^{-1/2}(\partial\Omega)$ . Then,  $(\Pi^s \mathbf{\Psi}, \mathbf{V}\mathbf{\Psi}) \in L^2(\Omega) \times \mathbf{H}^1(\Omega)$  by virtue of (4.33), (4.34). Now, applying relations (4.10) and (4.11), we obtain

#### 5. The third Green identities.

*Proof.* For an arbitrary fixed  $\boldsymbol{y} \in \Omega$ , let  $B_{\epsilon}(\boldsymbol{y}) \subset \Omega$  be a ball with a small enough radius  $\epsilon$  and centre  $\boldsymbol{y} \in \Omega$ , and let  $\Omega_{\epsilon}(\boldsymbol{y}) = \Omega \setminus \overline{B}_{\epsilon}(\boldsymbol{y})$ . Since all the functions in (5.3) are smooth, the canonical conormal derivatives coincide with the classical ones, given by (2.6), and it is easy to show that when  $\epsilon \to 0$ , the first integral in (5.3) tends to 0, the second tends to  $-v_k(\boldsymbol{y})$ , while integrands in the remaining domain integrals are weakly singular and these integrals tend to the corresponding improper integrals, which leads us to (5.2) for  $(p, \boldsymbol{v}) \in \mathcal{D}(\overline{\Omega}) \times \mathcal{D}(\overline{\Omega}) \subset H^{1,0}(\Omega; \mathcal{A})$ .

Let us take the trace of the second equation in (5.28) restricting it to  $S_1$  and take the traction with the constant coefficient  $\mu = 1$  of both equations in (5.28) restricting it to  $S_2$ . Keeping in mind the jump relations given in Theorem 4.5 and notation (4.45), we arrive at the system of equations

$$r_{S_1} \mathring{\boldsymbol{\mathcal{V}}} \Psi^* - r_{S_1} \mathring{\boldsymbol{\mathcal{W}}} \widehat{\boldsymbol{\Phi}} = \mathbf{0} \text{ on } S_1,$$
  
$$r_{S_2} \mathring{\boldsymbol{\mathcal{W}}}' \Psi^* - r_{S_2} \mathring{\mathcal{L}} \widehat{\boldsymbol{\Phi}} = \mathbf{0} \text{ on } S_2,$$

where  $\widehat{\mathbf{\Phi}} := \mu \mathbf{\Phi}^*$ .

This BIE system has been studied in [9, Theorem 3.10] (see Theorem 7.1 below) which implies that it has only the trivial solution,  $\Psi^* = 0$ ,  $\widehat{\Phi} = 0$ .

6. **BDIE systems.** We aim to obtain two different BDIE systems for mixed BVP (2.9) following the procedure similar to the one employed for a scalar PDE in [1], [19] and [16] and references therein.

To this end, let the functions  $\Phi_0 \in H^{1/2}(\partial\Omega)$  and  $\Psi_0 \in H^{-1/2}(\partial\Omega)$  be some continuations of the boundary functions  $\varphi_0 \in H^{1/2}(\partial\Omega_D)$  and  $\psi_0 \in H^{-1/2}(\partial\Omega_N)$ from (2.9c) and (2.9d). Let us now represent

$$\gamma^+ \boldsymbol{v} = \boldsymbol{\Phi}_0 + \boldsymbol{\varphi}, \quad \boldsymbol{T}^+(p, \boldsymbol{v}) = \boldsymbol{\Psi}_0 + \boldsymbol{\psi} \text{ on } \partial\Omega,$$
(6.1)

where  $\boldsymbol{\varphi} \in \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_N)$  and  $\boldsymbol{\psi} \in \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_D)$  are unknown boundary functions.

6.1. **BDIE system (M11**<sub>\*</sub>). Let us now take equations (5.14) and (5.15) in the domain  $\Omega$  and restrictions of equations (5.16) and (5.17) to the boundary parts  $\partial \Omega_D$  and  $\partial \Omega_N$ , respectively. Substituting there representations (6.1) and considering further the unknown boundary functions  $\varphi$  and  $\psi$  as formally independent of (segregated from) the unknown domain functions p and v, we obtain the following system (M11<sub>\*</sub>) of four boundary-domain integral equations for four unknowns,  $(p, v) \in H^{1,0}(\Omega, \mathcal{A}), \varphi \in \widetilde{H}^{1/2}(\partial \Omega_N)$  and  $\psi \in \widetilde{H}^{-1/2}(\partial \Omega_D)$ :

$$p + \mathcal{R}^{\bullet} \boldsymbol{v} - \Pi^{s} \boldsymbol{\psi} + \Pi^{d} \boldsymbol{\varphi} = F_{0} \quad \text{in } \Omega,$$
(6.2a)

$$\boldsymbol{v} + \boldsymbol{\mathcal{R}}\boldsymbol{v} - \boldsymbol{V}\boldsymbol{\psi} + \boldsymbol{W}\boldsymbol{\varphi} = \boldsymbol{F} \quad \text{in } \boldsymbol{\Omega}, \tag{6.2b}$$

$$r_{\partial\Omega_D} \boldsymbol{\gamma}^+ \boldsymbol{\mathcal{R}} \boldsymbol{v} - r_{\partial\Omega_D} \boldsymbol{\mathcal{V}} \boldsymbol{\psi} + r_{\partial\Omega_D} \boldsymbol{\mathcal{W}} \boldsymbol{\varphi} = r_{\partial\Omega_D} \boldsymbol{\gamma}^+ \boldsymbol{F} - \boldsymbol{\varphi}_0 \quad \text{on } \partial\Omega_D, \quad (6.2c)$$

$$r_{\partial\Omega_N} \boldsymbol{T}^+(\mathcal{R}^{\bullet}, \mathcal{R}) \boldsymbol{v} - r_{\partial\Omega_N} \boldsymbol{\mathcal{W}}' \boldsymbol{\psi} + r_{\partial\Omega_N} \boldsymbol{\mathcal{L}}^+ \boldsymbol{\varphi} = r_{\partial\Omega_N} \boldsymbol{T}^+(F_0, \boldsymbol{F}) - \boldsymbol{\psi}_0 \quad \text{on } \partial\Omega_N,$$
(6.2d)

where

$$F_0 = \mathring{\mathcal{Q}}\boldsymbol{f} + \frac{4}{3}g\mu + \Pi^s \boldsymbol{\Psi}_0 - \Pi^d \boldsymbol{\Phi}_0, \quad \boldsymbol{F} = \mathcal{U}\boldsymbol{f} - \mathcal{Q}g + \boldsymbol{V}\boldsymbol{\Psi}_0 - \boldsymbol{W}\boldsymbol{\Phi}_0.$$
(6.3)

By Theorems 4.1 and 4.3,  $(F_0, F) \in H^{1,0}(\Omega, \mathcal{A})$  and hence  $T(F_0, F)$  is well defined. Let us denote the right hand side of BDIE system (6.2) as

$$\mathcal{F}_{*}^{11} = [F_{0}, \boldsymbol{F}, r_{\partial\Omega_{D}} \gamma^{+} \boldsymbol{F} - \boldsymbol{\varphi}_{0}, r_{\partial\Omega_{N}} \boldsymbol{T}^{+}(F_{0}, \boldsymbol{F}) - \boldsymbol{\psi}_{0}].$$
(6.4)

Then Theorems 4.1 and 4.3 imply the inclusion  $\mathcal{F}^{11}_* \in H^{1,0}(\Omega, \mathcal{A}) \times H^{1/2}(\partial \Omega_D) \times H^{-1/2}(\partial \Omega_N)$ .

**Remark 6.1.** Let  $\mathcal{F}_*^{11}$  be defined by (6.3), (6.4). Then  $\mathcal{F}_*^{11} = \mathbf{0}$  if and only if  $(f, g, \Phi_0, \Psi_0) = \mathbf{0}$ .

Indeed, from (6.3) and (6.4) we immediately obtain that  $(\boldsymbol{f}, g, \boldsymbol{\Phi}_0, \boldsymbol{\Psi}_0) = 0$  implies  $\mathcal{F}_*^{11} = 0$ . Let us now prove that if  $\mathcal{F}_*^{11} = 0$  then  $(\boldsymbol{f}, g, \boldsymbol{\Phi}_0, \boldsymbol{\Psi}_0) = 0$ . Lemma 5.2 with  $F_0 = 0$  for p and  $\boldsymbol{F} = 0$  for  $\boldsymbol{v}$  applied to equations (6.3) implies that  $\boldsymbol{f} = 0$ , g = 0 and

$$\Pi^{s} \boldsymbol{\Psi}_{0} - \Pi^{d} \boldsymbol{\Phi}_{0} = 0, \quad \boldsymbol{V} \boldsymbol{\Psi}_{0} - \boldsymbol{W} \boldsymbol{\Phi}_{0} = 0 \quad \text{in } \Omega.$$
(6.5)

In addition, since  $F_0 = 0$  and F = 0, we get from (6.4) that

$$r_{\partial\Omega_D} \Phi_0 = \varphi_0 = \mathbf{0}, \quad r_{\partial\Omega_N} \Psi_0 = \psi_0 = \mathbf{0}.$$

Consequently,  $\Psi_0 \in \widetilde{H}^{-1/2}(\partial \Omega_D)$ ,  $\Phi_0 \in \widetilde{H}^{1/2}(\partial \Omega_N)$  and by (6.5) and Lemma 5.3 we obtain that  $\Psi_0 = 0$  and  $\Phi_0 = 0$  on  $\partial \Omega$ .

6.2. **BDIE system (M22**<sub>\*</sub>). Let us take equations (5.14) and (5.15) in the domain  $\Omega$  and restrictions of equations (5.16) and (5.17) to the boundary parts  $\partial \Omega_N$  and  $\partial \Omega_D$  respectively. Substituting there representations (6.1) and considering again the unknown boundary functions  $\varphi$  and  $\psi$  as formally independent of (segregated from) the unknown domain functions p and v, we obtain the following system (M22<sub>\*</sub>) of

four BDIEs for  $(p, \boldsymbol{v}) \in \boldsymbol{H}^{1,0}(\Omega, \boldsymbol{\mathcal{A}}), \, \boldsymbol{\varphi} \in \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_N) \text{ and } \boldsymbol{\psi} \in \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_D),$ 

$$p + \mathcal{R}^{\bullet} \boldsymbol{v} - \Pi^{s} \boldsymbol{\psi} + \Pi^{d} \boldsymbol{\varphi} = F_{0} \quad in \ \Omega,$$
(6.6a)

$$\boldsymbol{v} + \boldsymbol{\mathcal{R}}\boldsymbol{v} - \boldsymbol{V}\boldsymbol{\psi} + \boldsymbol{W}\boldsymbol{\varphi} = \boldsymbol{F} \quad in \ \Omega,$$
 (6.6b)

$$\frac{1}{2}\boldsymbol{\psi} + r_{\partial\Omega_{D}}\boldsymbol{T}^{+}(\boldsymbol{\mathcal{R}}^{\bullet},\boldsymbol{\mathcal{R}})\boldsymbol{v} - r_{\partial\Omega_{D}}\boldsymbol{\mathcal{W}}^{\prime}\boldsymbol{\psi} + r_{\partial\Omega_{D}}\boldsymbol{\mathcal{L}}^{+}\boldsymbol{\varphi} = r_{\partial\Omega_{D}}\boldsymbol{T}^{+}(F_{0},\boldsymbol{F}) - r_{\partial\Omega_{D}}\boldsymbol{\Psi}_{0}$$
on  $\partial\Omega_{D},$ 
(6.6c)

$$\frac{1}{2}\boldsymbol{\varphi} + r_{\partial\Omega_N}\boldsymbol{\gamma}^{\dagger}\boldsymbol{\mathcal{R}}\boldsymbol{v} - r_{\partial\Omega_N}\boldsymbol{\mathcal{V}}\boldsymbol{\psi} + r_{\partial\Omega_N}\boldsymbol{\mathcal{W}}\boldsymbol{\varphi} = r_{\partial\Omega_N}\boldsymbol{\gamma}^{\dagger}\boldsymbol{F} - r_{\partial\Omega_N}\boldsymbol{\Phi}_0$$
  
on  $\partial\Omega_N$ ,  
(6.6d)

where the terms  $F_0$  and F in the right hand side are given by (6.3).

Let us denote the right hand side of BDIE system (6.6) as

$$\mathcal{F}_{*}^{22} = [F_{0}, \boldsymbol{F}, r_{\partial\Omega_{D}}\boldsymbol{T}^{+}(F_{0}, \boldsymbol{F}) - r_{\partial\Omega_{D}}\boldsymbol{\Psi}_{0}, r_{\partial\Omega_{N}}\boldsymbol{\gamma}^{+}\boldsymbol{F} - r_{\partial\Omega_{N}}\boldsymbol{\Phi}_{0}].$$
(6.7)

Then Theorems 4.1 and 4.3 imply the inclusion  $\mathcal{F}^{22}_* \in H^{1,0}(\Omega, \mathcal{A}) \times H^{-1/2}(\partial \Omega_D) \times H^{1/2}(\partial \Omega_N)$ .

Note that the BDIE system (6.6a)-(6.6d) can be split into the BDIE system (M22) of 3 vector equations, (6.6b)-(6.6d), for 3 vector unknowns,  $\boldsymbol{v}, \boldsymbol{\psi}$  and  $\boldsymbol{\varphi}$ , and the separate equation (6.6a) that can be used, after solving the system, to obtain the pressure, p. However, since the couple  $(p, \boldsymbol{v})$  shares the space  $\boldsymbol{H}^{1,0}(\Omega, \boldsymbol{\mathcal{A}})$ , equations (6.6b), (6.6c) and (6.6d) are not completely separate from equation (6.6a).

**Remark 6.2.** Let  $\mathcal{F}_*^{22}$  be given by (6.3), (6.7). Then  $\mathcal{F}_*^{22} = \mathbf{0}$  if and only if  $(\mathbf{f}, g, \mathbf{\Phi}_0, \mathbf{\Psi}_0) = 0$ . Indeed, it is evident that  $(\mathbf{f}, g, \mathbf{\Phi}_0, \mathbf{\Psi}_0) = 0$  implies  $\mathcal{F}_*^{22} = 0$ . Let now  $\mathcal{F}_*^{22} = 0$ . Lemma 5.2 with  $F_0 = 0$  for p and  $\mathbf{F} = 0$  for v applied to equations (6.3) implies that  $\mathbf{f} = 0, g = 0$  and

$$\Pi^s \Psi_0 - \Pi^d \Phi_0 = 0, \quad V \Psi_0 - W \Phi_0 = 0 \quad \text{in } \Omega.$$
(6.8)

In addition, since  $F_0 = 0$  and F = 0, we get from (6.7) that

$$r_{\partial\Omega_D}\Psi_0 = 0, \quad r_{\partial\Omega_N}\Phi_0 = 0.$$

Consequently,  $\Psi_0 \in \widetilde{H}^{-1/2}(\partial \Omega_N)$  and  $\Phi_0 \in \widetilde{H}^{1/2}(\partial \Omega_D)$ . Therefore by (6.8) and Lemma 5.3 we obtain that  $\Psi_0 = 0$  and  $\Phi_0 = 0$  on  $\partial \Omega$ .

## 6.3. Equivalence of BDIE systems and BVP.

**Theorem 6.3** (Equivalence Theorem). Let  $\boldsymbol{f} \in \boldsymbol{L}_2(\Omega)$ ,  $g \in L_2(\Omega)$  and let  $\boldsymbol{\Phi}_0 \in \boldsymbol{H}^{-1/2}(\partial\Omega)$  and  $\boldsymbol{\Psi}_0 \in \boldsymbol{H}^{-1/2}(\partial\Omega)$  be some fixed extensions of  $\boldsymbol{\varphi}_0 \in \boldsymbol{H}^{1/2}(\partial\Omega_D)$  and  $\boldsymbol{\psi}_0 \in \boldsymbol{H}^{-1/2}(\partial\Omega_N)$  respectively.

(i) If a couple  $(p, v) \in L_2(\Omega) \times H^1(\Omega)$  solves the mixed BVP (2.9), then the set  $(p, v, \psi, \varphi)$  where

$$\varphi = \gamma^+ \boldsymbol{v} - \boldsymbol{\Phi}_0, \quad \boldsymbol{\psi} = \boldsymbol{T}^+(p, \boldsymbol{v}) - \boldsymbol{\Psi}_0 \quad on \; \partial\Omega,$$
 (6.9)

belongs to  $\mathbf{H}^{1,0}(\Omega; \mathbf{A}) \times \widetilde{\mathbf{H}}^{-1/2}(\partial \Omega_D) \times \widetilde{\mathbf{H}}^{1/2}(\partial \Omega_N)$  and solves BDIE systems (6.2) and (6.6).

- (ii) If a set  $(p, v, \psi, \varphi) \in L_2(\Omega) \times H^1(\Omega) \times \widetilde{H}^{-1/2}(\partial \Omega_D) \times \widetilde{H}^{1/2}(\partial \Omega_N)$  solves one of BDIE systems, (6.2) or (6.6), then it solves the other BDIE system, the couple (p, v) belongs to  $H^{1,0}(\Omega; \mathcal{A})$  and solves mixed BVP (2.9), while  $\psi, \varphi$ satisfy (6.9).
- (iii) Both BDIE systems, (6.2) and (6.6), are uniquely solvable for  $(p, \boldsymbol{v}, \boldsymbol{\psi}, \boldsymbol{\varphi}) \in L_2(\Omega) \times \boldsymbol{H}^1(\Omega) \times \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_D) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_N).$

Proof. (i) Let  $(p, v) \in L_2(\Omega) \times H^1(\Omega)$  be a solution of BVP (2.9). Since  $f \in L_2(\Omega)$ then  $(p, v) \in H^{1,0}(\Omega; \mathcal{A})$ . Let us define the functions  $\varphi$  and  $\psi$  by (6.9). By the BVP boundary conditions,  $\gamma^+ v = \varphi_0 = \Phi_0$  on  $\partial\Omega_D$  and  $T^+(p, v) = \psi_0 = \Psi_0$ on  $\partial\Omega_N$ . Then (6.9) implies that  $(\psi, \varphi) \in \widetilde{H}^{-1/2}(\partial\Omega_D) \times \widetilde{H}^{1/2}(\partial\Omega_N)$ . Taking into account the third Green identities (5.14)-(5.17), we immediately obtain that  $(p, v, \varphi, \psi)$  solves BDIE systems (6.2) and and (6.6).

(ii-11) Let  $(p, \boldsymbol{v}, \boldsymbol{\psi}, \boldsymbol{\varphi}) \in L_2(\Omega) \times \boldsymbol{H}^1(\Omega) \times \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_D) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_N)$  solve BDIE system (6.2). Then equations (6.2a), (6.2b) and Theorems 4.1, 4.3 imply that  $(p, \boldsymbol{v}, \boldsymbol{\psi}, \boldsymbol{\varphi}) \in \boldsymbol{H}^{1,0}(\Omega; \boldsymbol{\mathcal{A}}) \times \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_D) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_N)$  and the canonical conormal derivative  $\boldsymbol{T}^+(p, \boldsymbol{v})$  is well defined. If we take the trace of (6.2b) restricted to  $\partial \Omega_D$ , use the jump relations for the trace of  $\boldsymbol{V}$  and  $\boldsymbol{W}$ , see Theorem 4.5, and subtract it from (6.2c), we arrive at  $r_{\partial \Omega_D} \gamma^+ \boldsymbol{v} - \frac{1}{2} r_{\partial \Omega_D} \boldsymbol{\varphi} = \boldsymbol{\varphi}_0$  on  $\partial \Omega_D$ . Since  $\boldsymbol{\varphi}$  vanishes on  $\partial \Omega_D$ , the Dirichlet condition (2.9c) is satisfied. Repeating the same procedure but now taking the traction of (6.2a) and (6.2b), restricted to  $\partial\Omega_N$ , using the jump relations for the traction of  $(\Pi^d, \boldsymbol{W})$  and subtracting it from (6.2d), we arrive at  $r_{\partial\Omega_N} \boldsymbol{T}(p, \boldsymbol{v}) - \frac{1}{2}r_{\partial\Omega_N} \boldsymbol{\psi} = \boldsymbol{\psi}_0$  on  $\partial\Omega_N$ . Since  $\boldsymbol{\psi}$ vanishes on  $\partial\Omega_N$ , the Neumann condition (2.9d) is satisfied.

Because  $\varphi_0 = \Phi_0$ , on  $\partial \Omega_D$ ; and  $\psi_0 = \Psi_0$ , on  $\partial \Omega_N$ , we also obtain,

$$\Psi^* := \psi + \Psi_0 - T^+(p, v) \in \widetilde{H}^{-1/2}(\partial \Omega_D), \quad \Phi^* = \varphi + \Phi_0 - \gamma^+ v \in \widetilde{H}^{1/2}(\partial \Omega_N).$$
(6.10)

By relations (6.2a) and (6.2b) the hypotheses of Lemma 5.2 are satisfied with  $\Psi = \psi + \Psi_0$  and  $\Phi = \varphi + \Phi_0$ . As a result, we obtain that the couple (p, v) satisfies (2.9a) and (2.9c) and, moreover,

$$\Pi^{s}(\boldsymbol{\Psi}^{*}) - \Pi^{d}(\boldsymbol{\Phi}^{*}) = 0, \quad \boldsymbol{V}(\boldsymbol{\Psi}^{*}) - \boldsymbol{W}(\boldsymbol{\Phi}^{*}) = \boldsymbol{0} \quad \text{in } \Omega$$
(6.11)

Due to inclusions (6.10) and relations (6.11), Lemma 5.3 for  $S_1 = \partial \Omega_D$ , and  $S_2 = \partial \Omega_N$  implies  $\Psi^* = \Phi^* = \mathbf{0}$  on  $\partial \Omega$  and thus conditions (6.9).

Hence, by item (i) the set  $(p, v, \psi, \varphi)$  solves also BDIE system (6.6).

(ii-22) Let now  $(p, \boldsymbol{v}, \boldsymbol{\psi}, \boldsymbol{\varphi}) \in L_2(\Omega) \times \boldsymbol{H}^1(\Omega) \times \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_D) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_N)$  solve BDIE system (6.6). Then equations (6.6a), (6.6b) and Theorems 4.1, 4.3 imply that  $(p, \boldsymbol{v}, \boldsymbol{\psi}, \boldsymbol{\varphi}) \in \boldsymbol{H}^{1,0}(\Omega; \boldsymbol{\mathcal{A}}) \times \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_D) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_N)$  and the canonical conormal derivative  $\boldsymbol{T}^+(p, \boldsymbol{v})$  is well defined. Applying Lemma 5.2 with  $\boldsymbol{\Psi} = \boldsymbol{\psi} + \boldsymbol{\Psi}_0$  and  $\boldsymbol{\Phi} = \boldsymbol{\varphi} + \boldsymbol{\Phi}_0$  to BDIEs (6.6a)-(6.6b), we deduce that the couple  $(p, \boldsymbol{v})$  solves PDE system (2.9a)-(2.9b) and

$$\Pi^{s}(\boldsymbol{\Psi}^{*}) - \Pi^{d}(\boldsymbol{\Phi}^{*}) = 0, \qquad \boldsymbol{V}(\boldsymbol{\Psi}^{*}) - \boldsymbol{W}(\boldsymbol{\Phi}^{*}) = \boldsymbol{0}, \quad \text{in } \Omega, \tag{6.12}$$

where

$$\Psi^* := \psi + \Psi_0 - T^+(p, v), \qquad \Phi^* := \varphi + \Phi_0 - \gamma^+ v, \qquad on \quad \partial\Omega.$$
(6.13)

Taking the traction of (6.6a) and (6.6b) restricted to  $\partial \Omega_D$  and subtracting it from (6.6c) we get

$$\mathbf{r}_{\partial\Omega_D} \mathbf{T}^+(p, \mathbf{v}) - r_{\partial\Omega_D} \mathbf{\Psi}_0 = \mathbf{\psi}, \quad on \quad \partial\Omega_D.$$
(6.14)

Taking the trace of (6.6b) restricted to  $\partial \Omega_N$  and subtracting it from (6.6d) we get

$$r_{\partial\Omega_N}\gamma^+\boldsymbol{v} - r_{\partial\Omega_N}\boldsymbol{\Phi}_0 = \boldsymbol{\varphi}, \quad on \quad \partial\Omega_N.$$
(6.15)

Due to (6.14) and (6.15), we have  $\Psi^* \in \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_D)$  and  $\Phi^* \in \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_N)$ . Now, we can apply Lemma 5.3 with  $S_1 = \partial \Omega_D$  and  $S_2 = \partial \Omega_N$ , to obtain  $\Psi^* = \Phi^* = \mathbf{0}$  on  $\partial \Omega$ , which by (6.13) imply relations (6.9). Since  $r_{\partial \Omega_D} \Phi_0 = \phi_0$  and  $r_{\partial \Omega_N} \Psi_0 = \psi_0$ , relations (6.9) imply boundary conditions (2.9c) and (2.9d).

(iii) Finally, the unique solvability of the BDIE systems (6.2) and (6.6) in item (iii) follows from the unique solvability of the BVP, see Theorem 2.3, and items (i) and (ii).

6.4. Boundary integral equations. When  $\mu \equiv 1$ , the operator  $\mathcal{A}$  becomes  $\mathcal{A}$  and  $\mathcal{R} = \mathcal{R}^{\bullet} \equiv 0$ . Consequently, the boundary-domain integral equations system (6.2) can be split into a system of two vector boundary integral equations,

$$r_{\partial\Omega_D}(-\dot{\boldsymbol{\mathcal{V}}}\psi+\dot{\boldsymbol{\mathcal{W}}}\varphi)=r_{\partial\Omega_D}\boldsymbol{\gamma}^+\boldsymbol{F}-\boldsymbol{\varphi}_0,\quad\text{on }\partial\Omega_D,\tag{6.16}$$

$$r_{\partial\Omega_N}(-\dot{\mathcal{W}}'\psi+\dot{\mathcal{L}}\varphi)=r_{\partial\Omega_N}T^+(F_0,F)-\psi_0,\quad\text{on }\partial\Omega_N,\tag{6.17}$$

and two integral representations, for p and v,

$$p = F_0 + \mathring{\Pi}^s \psi - \mathring{\Pi}^d \varphi \text{ in } \Omega, \qquad (6.18)$$

$$\boldsymbol{v} = \boldsymbol{F} + \check{\boldsymbol{V}}\boldsymbol{\psi} - \check{\boldsymbol{W}}\boldsymbol{\varphi} \text{ in } \boldsymbol{\Omega}, \qquad (6.19)$$

where  $F_0$  and F are given by (6.3).

Similarly, the boundary-domain integral equations system (6.6) can be split into a system of two vector boundary integral equations, for  $\psi$  and  $\varphi$ ,

$$r_{\partial\Omega_D}\left(\frac{1}{2}\boldsymbol{\psi}-\boldsymbol{\mathcal{W}}\boldsymbol{\mathcal{V}}\boldsymbol{\psi}+\boldsymbol{\mathcal{L}}\boldsymbol{\varphi}\right)=r_{\partial\Omega_D}\boldsymbol{T}^+(F_0,\boldsymbol{F})-r_{\partial\Omega_D}\boldsymbol{\Psi}_0 \text{ on } \partial\Omega_D, \qquad (6.20)$$

$$r_{\partial\Omega_N}\left(\frac{1}{2}\boldsymbol{\varphi} - \mathring{\boldsymbol{\mathcal{V}}}\boldsymbol{\psi} + \mathring{\boldsymbol{\mathcal{W}}}\boldsymbol{\varphi}\right) = r_{\partial\Omega_N}\boldsymbol{\gamma}^+\boldsymbol{F} - r_{\partial\Omega_N}\boldsymbol{\Phi}_0 \text{ on } \partial\Omega_N \qquad (6.21)$$

and two integral representations, (6.18) and (6.19), for p and v.

Equivalence Theorem 6.3 for BDIE system (6.3) leads to the following equivalence assertion for the constant coefficient case.

**Corollary 6.4.** Let  $\mu \equiv 1$ ,  $\boldsymbol{f} \in \boldsymbol{L}^2(\Omega)$  and  $g \in L^2(\Omega)$ . Moreover, let  $\boldsymbol{\Phi}_0 \in \boldsymbol{H}^{1/2}(\partial\Omega)$  and  $\boldsymbol{\Psi}_0 \in \boldsymbol{H}^{-1/2}(\partial\Omega)$  be some extensions of  $\boldsymbol{\varphi}_0 \in \boldsymbol{H}^{1/2}(\partial\Omega_D)$  and  $\boldsymbol{\psi}_0 \in \boldsymbol{H}^{-1/2}(\partial\Omega_N)$ , respectively.

(i) If a couple  $(p, v) \in L_2(\Omega) \times H^1(\Omega)$  solves BVP (2.9), then the solution is unique, the couple  $(\psi, \varphi) \in \widetilde{H}^{-1/2}(\partial \Omega_D) \times \widetilde{H}^{1/2}(\partial \Omega_N)$  given by

$$\boldsymbol{\varphi} = \gamma^+ \boldsymbol{v} - \boldsymbol{\Phi}_0, \quad \boldsymbol{\psi} = \boldsymbol{T}^+(p, \boldsymbol{v}) - \boldsymbol{\Psi}_0 \quad on \; \partial\Omega,$$
(6.22)

solves BIE systems (6.16)-(6.17) and (6.20)-(6.21), and the couple (p, v) satisfies (6.18), (6.19).

(ii) If a couple  $(\psi, \varphi) \in \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_D) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_N)$  solves one of BIE system, (6.16)-(6.17) or (6.20)-(6.21), then it solves the other BDIE system, the couple  $(p, \boldsymbol{v})$  given by (6.18)-(6.19) belongs to  $\boldsymbol{H}^{1,0}(\Omega; \mathcal{A})$  and solves BVP (2.9), while  $\psi, \varphi$  satisfy relations (6.22).

(iii) Both systems (6.16)-(6.17) and (6.20)-(6.21) are uniquely solvable for  $(\psi, \varphi) \in \widetilde{H}^{-1/2}(\partial \Omega_D) \times \widetilde{H}^{1/2}(\partial \Omega_N).$ 

### 7. BDIE operators invertibility.

7.1. Operators  $\mathcal{M}^{11}_*$  and  $\mathcal{M}^{11}$ . BDIE system (6.2) can be written using matrix notation as

$$\mathcal{M}_*^{11}\mathcal{X} = \mathcal{F}_*^{11},\tag{7.1}$$

where

$$\mathcal{M}_{*}^{11} = \begin{bmatrix} I & \mathcal{R}^{\bullet} & -\Pi^{s} & \Pi^{d} \\ \mathbf{0} & I + \mathcal{R} & -\mathbf{V} & \mathbf{W} \\ \mathbf{0} & r_{\partial\Omega_{D}} \boldsymbol{\gamma}^{+} \mathcal{R} & -r_{\partial\Omega_{D}} \boldsymbol{\mathcal{V}} & r_{\partial\Omega_{D}} \mathcal{W} \\ \mathbf{0} & r_{\partial\Omega_{N}} \mathbf{T}^{+} (\mathcal{R}^{\bullet}, \mathcal{R}) & -r_{\partial\Omega_{N}} \mathcal{W}' & r_{\partial\Omega_{N}} \mathcal{L}^{+} \end{bmatrix}$$
(7.2)

and  $\mathcal{X} = (p, v, \psi, \varphi)$ . By Theorems 4.1-4.4 the mapping properties of the operators involved in the matrix imply continuity of the operator

$$\mathcal{M}^{11}_*: \boldsymbol{H}^{1,0}(\Omega, \boldsymbol{\mathcal{A}}) \times \widetilde{\boldsymbol{\mathcal{H}}}^{-1/2}(\partial \Omega_D) \times \widetilde{\boldsymbol{\mathcal{H}}}^{1/2}(\partial \Omega_N) \rightarrow \boldsymbol{H}^{1,0}(\Omega, \boldsymbol{\mathcal{A}}) \times \boldsymbol{H}^{1/2}(\partial \Omega_D) \times \boldsymbol{H}^{-1/2}(\partial \Omega_N).$$
(7.3)

We can also consider the operator  $\mathcal{M}^{11}_*$ , defined by (7.2), in wider spaces,

$$\mathcal{M}^{11}_*: L_2(\Omega) \times \boldsymbol{H}^1(\Omega) \times \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_D) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_N) \rightarrow L_2(\Omega) \times \boldsymbol{H}^1(\Omega) \times \boldsymbol{H}^{1/2}(\partial \Omega_D) \times \boldsymbol{H}^{-1/2}(\partial \Omega_N)$$
(7.4)

Theorems 4.1-4.4 imply that operator (7.4) is also continuous.

Let us also write BIE system (6.16)-(6.17), for  $\mu \equiv 1$ , in the matrix form as

$$\mathring{\mathcal{M}}^{11}\mathring{\mathcal{X}} = \mathring{\mathcal{F}}^{11},\tag{7.5}$$

where  $\mathring{\mathcal{X}} = (\psi, \varphi), \, \mathring{\mathcal{F}}^{11} = \begin{bmatrix} r_{\partial \Omega_N} T^+(F_0, F) - \psi_0 \end{bmatrix}$  and  $\mathring{\mathcal{M}}^{11} = \begin{bmatrix} -r_{\partial \Omega_D} \mathring{\mathcal{V}} & r_{\partial \Omega_D} \mathring{\mathcal{W}} \\ -r_{\partial \Omega_N} \mathring{\mathcal{W}}' & r_{\partial \Omega_N} \mathring{\mathcal{L}} \end{bmatrix}.$ (7.6)

The following assertion is implied by [9, Theorem 3.10].

Theorem 7.1. The operator

$$\overset{\circ}{\mathcal{M}}^{11}: \widetilde{\boldsymbol{H}}^{-1/2}(\partial\Omega_D) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial\Omega_N) \to \boldsymbol{H}^{1/2}(\partial\Omega_D) \times \boldsymbol{H}^{-1/2}(\partial\Omega_N)$$
(7.7)

is continuous and continuously invertible.

Theorem 7.1 will be instrumental in proving the following result.

**Theorem 7.2.** Operators (7.3) and (7.4) are continuously invertible.

*Proof.* (i) Let us start from operator (7.4). To this end let us define the operator

$$\widetilde{\mathcal{M}}^{11} = \begin{bmatrix} I & \mathcal{R}^{\bullet} & -\Pi^s & \Pi^d \\ \mathbf{0} & I & -\mathbf{V} & \mathbf{W} \\ \mathbf{0} & \mathbf{0} & -r_{\partial\Omega_D} \mathbf{\mathcal{V}} & r_{\partial\Omega_D} \mathbf{\mathcal{W}} \\ \mathbf{0} & \mathbf{0} & -r_{\partial\Omega_N} \mathbf{\mathcal{W}'} & r_{\partial\Omega_N} \mathbf{\widehat{\mathcal{L}}} \end{bmatrix},$$

and consider the new system

$$\widetilde{\mathcal{M}}^{11}\widetilde{\mathcal{X}} = \widetilde{\mathcal{F}}^{11} \tag{7.8}$$

where  $\widetilde{\mathcal{X}} = [\widetilde{p}, \widetilde{v}, \widetilde{\phi}, \widetilde{\psi}]^{\top} \in L_2(\Omega) \times H^1(\Omega) \times \widetilde{H}^{-1/2}(\partial\Omega_D) \times \widetilde{H}^{1/2}(\partial\Omega_N)$  and  $\widetilde{\mathcal{F}} = [\widetilde{\mathcal{F}}_1^{11}, \widetilde{\mathcal{F}}_2^{11}, \widetilde{\mathcal{F}}_4^{11}]^{\top} \in L_2(\Omega) \times H^1(\Omega) \times H^{1/2}(\partial\Omega_D) \times H^{-1/2}(\partial\Omega_N).$ Consider now, the last two equations of the system (7.8),

$$-r_{\partial\Omega_D} \mathcal{V}\tilde{\psi} + r_{\partial\Omega_D} \mathcal{W}\tilde{\phi} = \tilde{\mathcal{F}}_3^{11}, \qquad (7.9)$$

$$-r_{\partial\Omega_N} \dot{\mathcal{W}'} \tilde{\psi} + r_{\partial\Omega_N} \hat{\mathcal{L}} \tilde{\phi} = \tilde{\mathcal{F}}_4^{11}.$$
(7.10)

Multiplying equation (7.9) by  $\mu$  and applying relations (4.10) and (4.45) we obtain

$$-r_{\partial\Omega_D} \mathring{\mathcal{V}} \widetilde{\psi} + r_{\partial\Omega_D} \mathring{\mathcal{W}}(\mu \widetilde{\phi}) = \mu \widetilde{\mathcal{F}}_3^{11}, \qquad (7.11)$$

$$-r_{\partial\Omega_N} \dot{\mathcal{W}}' \tilde{\psi} + r_{\partial\Omega_N} \dot{\mathcal{L}}(\mu \tilde{\phi}) = \tilde{\mathcal{F}}_4^{11}.$$
(7.12)

This system is uniquely solvable for  $\tilde{\phi}$  and  $\tilde{\psi}$ , since the matrix operator of the left hand side is invertible, cf. Theorem 7.1. Hence  $\tilde{v}$  is uniquely determined from the second equation of the system (7.8) and thus, by the first equation, p is also uniquely defined. This proves the invertibility of the operator  $\widetilde{\mathcal{M}}^{11}$ , which implies that  $\widetilde{\mathcal{M}}^{11}$  is a Fredholm operator with zero index.

Furthermore, the operator

$$\mathcal{M}^{11}_* - \widetilde{\mathcal{M}}^{11} : L_2(\Omega) \times \boldsymbol{H}^1(\Omega) \times \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_D) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_N) \rightarrow L_2(\Omega) \times \boldsymbol{H}^1(\Omega) \times \boldsymbol{H}^{1/2}(\partial \Omega_D) \times \boldsymbol{H}^{-1/2}(\partial \Omega_N)$$

is compact due to Theorems 4.2, 4.4 and 4.7. Thus operator (7.4) is also a Fredholm operator with zero index. By virtue of the Equivalence Theorem 6.3 and Remark 6.1, the homogeneous system (M11) has only the trivial solution, hence operator (7.4) is invertible.

(ii) Let us now consider operator (7.3). Let  $\mathcal{X} = (\mathcal{M}_*^{11})^{-1} \mathcal{F}_*^{11}$  be the solution of system (7.1) with an arbitrary right hand side  $\mathcal{F}_*^{11} \in L^2(\Omega) \times H^1(\Omega) \times H^{1/2}(\partial \Omega_D) \times H^{-1/2}(\partial \Omega_N)$ , where

$$(\mathcal{M}^{11}_*)^{-1}: L_2(\Omega) \times \boldsymbol{H}^1(\Omega) \times \boldsymbol{H}^{1/2}(\partial \Omega_D) \times \boldsymbol{H}^{-1/2}(\partial \Omega_N) \to L_2(\Omega) \times \boldsymbol{H}^1(\Omega) \times \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_D) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_N)$$

is the inverse of operator (7.4).

If, moreover,  $\mathcal{F}_{*}^{11} \in \mathcal{H}^{1,0}(\Omega, \mathcal{A}) \times \mathcal{H}^{1/2}(\partial\Omega_{D}) \times \mathcal{H}^{-1/2}(\partial\Omega_{N})$ , then the first two equations of system (7.1) and the mapping properties of the operators in these equations imply that  $\mathcal{X} \in \mathcal{H}^{1,0}(\Omega; \mathcal{A}) \times \widetilde{\mathcal{H}}^{-1/2}(\partial\Omega_{D}) \times \widetilde{\mathcal{H}}^{1/2}(\partial\Omega_{N})$ . Consequently, the operator

$$(\mathcal{M}^{11}_*)^{-1}: L_2(\Omega) \times \boldsymbol{H}^1(\Omega) \times \boldsymbol{H}^{1/2}(\partial \Omega_D) \times \boldsymbol{H}^{-1/2}(\partial \Omega_N) \rightarrow L_2(\Omega) \times \boldsymbol{H}^1(\Omega) \times \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_D) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_N)$$

is also continuous and is an inverse of operator (7.3).

Note that the BDIE system (M11<sub>\*</sub>) given by (6.2) can be split into the BDIE system (M11), of 3 vector equations (6.2b), (6.2c), (6.2d) for 3 vector unknowns,  $\boldsymbol{v}$ ,  $\boldsymbol{\psi}$  and  $\boldsymbol{\varphi}$ , and the scalar equation (6.2a) that can be used, after solving the system, to obtain the pressure, p. Using matrix notation, equations (6.2b), (6.2c), (6.2d) can be written as

$$\mathcal{M}^{11}(\boldsymbol{v}, \boldsymbol{\psi}, \boldsymbol{\varphi})^{\top} = \mathcal{F}^{11}, \qquad (7.13)$$

where

$$\mathcal{M}^{11} = \begin{bmatrix} \mathbf{I} + \mathcal{R} & -\mathbf{V} & \mathbf{W} \\ r_{\partial \Omega_D} \gamma^+ \mathcal{R} & -r_{\partial \Omega_D} \mathcal{V} & r_{\partial \Omega_D} \mathcal{W} \\ r_{\partial \Omega_N} \mathbf{T}^+ (\mathcal{R}^{\bullet}, \mathcal{R}) & -r_{\partial \Omega_N} \mathcal{W}' & r_{\partial \Omega_N} \mathcal{L}^+ \end{bmatrix}.$$
(7.14)

Corollary 7.3. The operator

$$\mathcal{M}^{11}: \boldsymbol{H}^{1}(\Omega) \times \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_{D}) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_{N}) \rightarrow \boldsymbol{H}^{1}(\Omega) \times \boldsymbol{H}^{1/2}(\partial \Omega_{D}) \times \boldsymbol{H}^{-1/2}(\partial \Omega_{N})$$
(7.15)

is continuous and continuously invertible.

*Proof.* Operator (7.15) is continuous due to the mapping properties of the integral operators involved in (7.14).

By the same arguments as in part (i) of the proof of Theorem 7.2, we obtain that operator (7.15) is Fredholm with zero index. Complementing system (7.13) with an arbitrary right hand side  $\mathcal{F}^{11} \in \mathbf{H}^1(\Omega) \times \mathbf{H}^{1/2}(\partial\Omega_D) \times \mathbf{H}^{-1/2}(\partial\Omega_N)$  by equation (6.2a) with a right hand side  $F_0 \in L_2(\Omega)$ , we arrive at system (7.1) which is solvable in  $L_2(\Omega) \times \mathbf{H}^1(\Omega) \times \widetilde{\mathbf{H}}^{-1/2}(\partial\Omega_D) \times \widetilde{\mathbf{H}}^{1/2}(\partial\Omega_N)$ , due to Theorem 7.2 for operator

(7.4), and thus delivers a solution  $(\boldsymbol{v}, \boldsymbol{\psi}, \boldsymbol{\varphi}) \in \boldsymbol{H}^1(\Omega) \times \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_D) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_N)$  of system (7.13), which implies surjectivity of operator (7.15). To prove that the operator is also injective, we assume the opposite, which would imply that operator (7.4) is also non-injective thus contradicting its invertibility.

Let  $\mathcal{A}_M$  denote the operator of left hand side in the BVP (2.9).

**Corollary 7.4.** Let  $\mathbf{f} \in \mathbf{L}^2(\Omega)$ ,  $g \in L^2(\Omega)$ ,  $\phi_0 \in \mathbf{H}^{1/2}(\partial\Omega_D)$  and  $\psi_0 \in \mathbf{H}^{-1/2}(\partial\Omega_N)$  respectively. Then, the BVP (2.9) is uniquely solvable in  $\mathbf{H}^{1,0}(\Omega; \mathbf{A})$  and the operator

$$\mathcal{A}_M: H^{1,0}(\Omega; \mathcal{A}) \to L^2(\Omega) \times L^2(\Omega) \times H^{1/2}(\partial \Omega_D) \times H^{-1/2}(\partial \Omega_N)$$
(7.16)

$$(p, \boldsymbol{v}) \to \boldsymbol{\mathcal{A}}_M(p, \boldsymbol{v}) := (\boldsymbol{\mathcal{A}}(p, \boldsymbol{v}), \operatorname{div}(\boldsymbol{v}), r_{\partial\Omega_D}\gamma^+ \boldsymbol{v}, r_{\partial\Omega_N}\boldsymbol{T}^+(p, \boldsymbol{v}))$$
 (7.17)

is continuously invertible.

*Proof.* By Theorem 7.2 for operator (7.3), BDIE system (6.2) is uniquely solvable and by Theorem 6.3 it is equivalent to the BVP (2.9), which implies unique solvability of the latter. In addition, the inverse to operator (7.16) is defined as

$$\mathcal{A}_{M}^{-1}(\boldsymbol{f}, g, r_{\partial \Omega_{D}} \boldsymbol{\Phi}_{0}, r_{\partial \Omega_{N}} \boldsymbol{\Psi}_{0}) = [((\mathcal{M}_{*}^{11})^{-1} \mathcal{F}_{*}^{11})_{1}, ((\mathcal{M}_{*}^{11})^{-1} \mathcal{F}_{*}^{11})_{2}]$$

and is continuous since operator (7.3) is continuously invertible and  $\mathcal{F}^{11}_*$  continuously depends on  $(f, g, \Psi_0, \Phi_0)$  due to the mapping properties of the operators involved in (6.3) and (6.4).

7.2. Operators  $\mathcal{M}^{22}_*$  and  $\mathcal{M}^{22}$ . BDIE system (6.6) can be written in the matrix form as

$$\mathcal{M}_*^{22}\mathcal{X} = \mathcal{F}_*^{22},\tag{7.18}$$

where

$$\mathcal{M}_{*}^{22} = \begin{bmatrix} I & \mathcal{R}^{\bullet} & -\Pi^{s} & \Pi^{d} \\ \mathbf{0} & \mathbf{I} + \mathcal{R} & -\mathbf{V} & \mathbf{W} \\ \mathbf{0} & r_{\partial\Omega_{D}} \mathbf{T}^{+} (\mathcal{R}^{\bullet}, \mathcal{R}) & r_{\partial\Omega_{D}} \left(\frac{1}{2}\mathbf{I} - \mathcal{W}'\right) & r_{\partial\Omega_{D}} \mathcal{L}^{+} \\ \mathbf{0} & r_{\partial\Omega_{N}} \gamma^{+} \mathcal{R} & -r_{\partial\Omega_{N}} \mathcal{V} & r_{\partial\Omega_{N}} \left(\frac{1}{2}\mathbf{I} + \mathcal{W}\right) \end{bmatrix}, \quad (7.19)$$

and  $\mathcal{X} = (p, \boldsymbol{v}, \boldsymbol{\psi}, \boldsymbol{\varphi})$ . By Theorems 4.1-4.4, the mapping properties of the operators involved in (7.19) imply continuity of the operator

$$\mathcal{M}^{22}_*: \boldsymbol{H}^{1,0}(\Omega, \boldsymbol{\mathcal{A}}) \times \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_D) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_N) \rightarrow \boldsymbol{H}^{1,0}(\Omega, \boldsymbol{\mathcal{A}}) \times \boldsymbol{H}^{-1/2}(\partial \Omega_D) \times \boldsymbol{H}^{1/2}(\partial \Omega_N).$$
(7.20)

**Lemma 7.5.** Let  $\partial \Omega = \overline{S}_1 \cup \overline{S}_2$ , where  $S_1$  and  $S_2$  are two non-intersecting simply connected non-empty submanifolds of  $\partial \Omega$  with infinitely smooth boundaries. For any vector

$$\mathcal{F} = (F_0, \boldsymbol{F}, \boldsymbol{\Psi}, \boldsymbol{\Phi}) \in \boldsymbol{H}^{1,0}(\Omega; \mathcal{A}) \times \boldsymbol{H}^{-1/2}(S_1) \times \boldsymbol{H}^{1/2}(S_2)$$

there exists a unique four-tuple

$$(g_*, \boldsymbol{f}_*, \boldsymbol{\Psi}_*, \boldsymbol{\Phi}_*) = \widetilde{\mathcal{C}}_{S_1, S_2} \mathcal{F} \in L_2(\Omega) \times \boldsymbol{L}_2(\Omega) \times \boldsymbol{H}^{-1/2}(\partial \Omega) \times \boldsymbol{H}^{1/2}(\partial \Omega)$$

such that

The matrix operator given by the left-hand side of the equations (7.32) is an isomorphism between the spaces  $\widetilde{\boldsymbol{H}}^{-1/2}(S_2) \times \widetilde{\boldsymbol{H}}^{1/2}(S_1)$  and  $\boldsymbol{H}^{1/2}(S_2) \times \boldsymbol{H}^{-1/2}(S_1)$ (see Theorem 7.1). By (7.30)-(7.31), the couples have coinciding mixed boundary conditions and thus they coincide also in the domain  $\Omega$  by virtue of uniqueness of solution of the mixed BVP for the Stokes system with  $\mu = 1$ , i.e., equations (7.27) hold and substitution of (7.28), (7.29) into their right hand sides leads to (7.21a) and (7.21b).

To prove that the operator  $\widetilde{\mathcal{C}}_{S_1,S_2}$  is unique, let us consider system (7.21) with zero right-hand side  $\mathcal{F}$ . $$(a, b\mathbf{I}, c\mathbf{I}, d\mathbf{I}) = \begin{bmatrix} a & 0 & 0 & 0 \\ 0 & \mathbf{b} & 0 & 0 \\ 0 & 0 & \mathbf{c} & 0 \\ 0 & 0 & 0 & \mathbf{d} \end{bmatrix}$$
. (7.52)

The operator  $\widehat{\mathcal{M}}^{22}$  defined by (7.45) can be understood as a triangular block matrix operator with the three following diagonal operators

$$I: L^2(\Omega^+) \to L^2(\Omega^+), \tag{7.53}$$

$$I: \boldsymbol{H}^{1}(\Omega^{+}) \to \boldsymbol{H}^{1}(\Omega^{+}), \qquad (7.54)$$

$$\mathring{\mathcal{M}}^{22}: \ \widetilde{\boldsymbol{H}}^{-1/2}(\partial\Omega_D) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial\Omega_N) \to \boldsymbol{H}^{-1/2}(\partial\Omega_D) \times \boldsymbol{H}^{1/2}(\partial\Omega_N).$$
(7.55)

By Theorem 7.8, operator (7.55) is invertible. Consequently,

$$\widehat{\mathcal{M}}^{22}: L^{2}(\Omega) \times \boldsymbol{H}^{1}(\Omega) \times \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_{D}) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_{N}) \to L^{2}(\Omega) \times \boldsymbol{H}^{1}(\Omega) \times \boldsymbol{H}^{-1/2}(\partial \Omega_{D}) \times \boldsymbol{H}^{1/2}(\partial \Omega_{N})$$
(7.56)

is an invertible operator as well. As  $\mu$  is strictly positive, the diagonal matrices are invertible and the operator

$$\widetilde{\mathcal{M}}^{22}: L^{2}(\Omega) \times \boldsymbol{H}^{1}(\Omega) \times \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_{D}) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_{N}) \rightarrow L^{2}(\Omega) \times \boldsymbol{H}^{1}(\Omega) \times \boldsymbol{H}^{-1/2}(\partial \Omega_{D}) \times \boldsymbol{H}^{1/2}(\partial \Omega_{N})$$
(7.57)

is also invertible. Thus, operator (7.49) is a zero-index Fredholm operator. Invertibility of this operator then follows from its injectivity implied by Theorem 6.3(iii).

The last three vector equations of the system (M22) are segregated from p. Therefore, we can define the new system given by equations (6.6b)-(6.6d) which can be written in the matrix form as

$$\mathcal{M}^{22}\mathcal{Y} = \mathcal{F}^{22},\tag{7.58}$$

where  $\mathcal{Y}$  represents the vector containing the unknowns of the system

$$\mathcal{Y} = (\boldsymbol{v}, \boldsymbol{\psi}, \boldsymbol{\phi}) \in \boldsymbol{H}^1(\Omega) \times \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_D) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_N),$$

and the matrix operator  $\mathcal{M}^{22}$  is given by

$$\mathcal{M}^{22} := \begin{bmatrix} \mathbf{I} + \mathcal{R} & -\mathbf{V} & \mathbf{W} \\ r_{\partial \Omega_D} \mathbf{T}^+ (\mathcal{R}^{\bullet}, \mathcal{R}) & r_{\partial \Omega_D} \left(\frac{1}{2}\mathbf{I} - \mathcal{W}'\right) & r_{\partial \Omega_D} \mathcal{L}^+ \\ r_{\partial \Omega_N} \gamma^+ \mathcal{R} & -r_{\partial \Omega_N} \mathcal{V} & r_{\partial \Omega_N} \left(\frac{1}{2}\mathbf{I} + \mathcal{W}\right) \end{bmatrix}.$$
(7.59)

Following the reasoning similar to the proof of Corollary 7.3, we obtain the following assertion.

Corollary 7.10. The operator

$$\mathcal{M}^{22}: \boldsymbol{H}^{1}(\Omega) \times \widetilde{\boldsymbol{H}}^{-1/2}(\partial \Omega_{D}) \times \widetilde{\boldsymbol{H}}^{1/2}(\partial \Omega_{N}) \to \boldsymbol{H}^{1}(\Omega) \times \boldsymbol{H}^{-1/2}(\partial \Omega_{D}) \times \boldsymbol{H}^{1/2}(\partial \Omega_{N}),$$

is continuous and continuously invertible.
