On Eulerian and Lagrangean Objectivity

in Continuum Mechanics

<u>Abstract</u> In continuum mechanics the commonly—used definition of objectivity (or frame-indifference) of a tensor field does not distinguish between Eulerian, Lagrangean and two—point tensor fields. This paper highlights the distinction and provides a definition of objectivity which reflects the different transformation rules for Eulerian, Lagrangean and twopoint tensor fields under an observer transformation. The notion of <u>induced objectivity</u> is introduced and its implications examined. <u>1. Introduction.</u> With the motion of a deformable continuous body there are associated certain scalar quantities which can be regarded as intrinsic to the material constituting the body in the sense that all observers attach the same value to each such quantity. One example of such a scalar is the mass density of the material; another is the extension of an arbitrary line element of material. The speed of a material particle, on the other hand, depends on the choice of observer since different observers are in relative motion in general. These scalar quantities are measured in terms of scalar, vector and tensor fields which transform according to certain rules under a change of observer (or change of frame of reference †).

The purpose of this paper is to formalize the 'observer indifference of scalars described above by means of a definition which is reflected in the transformation rules of the associated vector and tensor fields under a change of observer. Fields satisfying this definition are said to be <u>objective</u>[†] An important consequence of the definition is that objective Eulerian and Lagrangean tensor fields have different transformation rules. This is emphasized because previous definitions of objectivity have not distinguished between Eulerian and Lagrangean tensor fields (see, for example, (<u>4</u>) and (<u>5</u>). Before discussing the notion of objectivity in detail, we summarize some basic ideas relating to observers.

Events (or phenomena) which occur in the physical world are manifest in space and time through the perception of what is referred to loosely as an 'observer'. We suppose that the space in which events are recorded by an 'observer' is the (three-dimensional) Euclidean point space E and that time is measured on the real line R. We may regard an 'observer' as being equipped to measure physical quantities and, in particular, to monitor the relative positions of points in E and the progress of time in R. Formally, an <u>observer</u>, 0 say, is defined as a mapping (in fact, a homeomorphism) which assigns a pair (\underline{x}, t) $\in E \times \mathbb{R}$

[†] The terms 'observer' and ' frame of reference' are often used synonymously, as also are 'objective' and "frame-indifferent'. [†][†] Here *E* is taken to be the same for all observers, but we note that more abstract work does not require such a restriction (<u>6</u>). to an event in the physical world, where <u>x</u> is the <u>place</u> and t the <u>time</u> of the event <u>as perceived by</u> 0 and E x R denotes the Cartesian product of E and \mathbb{R} .

Let x and x be points in E. Then the point difference $x \sim x_{-0}^{-0}$ is an element of the vector space, denoted E, which is called the <u>translation space</u> of E. The distance between the points x and x is a = 0denoted $|x \sim x_{-0}|$. Similarly, if t and t₀ are times in \mathbb{R} then t - t₀ is a time interval in \mathbb{R} (which may be positive or negative). Thus the events recorded by 0 as (x, t) and (x_0, t_0) are separated by distance $|x \sim x_{-0}|$ and time t - t₀.

In continuum mechanics it is stipulated that different observers should agree about (a) the distance between events, (b) time intervals between events and (c) the order in which events occur. This means that $\begin{vmatrix} x & x \\ z & 0 \end{vmatrix}$ and t - t₀ are preserved under a mapping from $E \ x \ R$ to $E \ x \ R$ which corresponds to a change of observer. Thus, if the events recorded by 0 as (x, t) and $x \atop_{0}^{*}, t_{0}^{*}$ are recorded by a second observer, 0^{*} say, as $(x \atop_{x}^{*}, t^{*})$ and $x \atop_{0}^{*}, t_{0}^{*}$ the most general one-to-one mapping from $E \ x \ R \ to \ E \ x \ R \ which satisfies these requirements is specified by the$ equations

where $a \in R$ is a constant and $\underset{\approx}{Q}(t)$ is an orthogonal (second-order) tensor (which can be regarded as a linear mapping from E to E[†]). Note that no preferred choice of origin for E is involved in (1).

The mapping from $E \ge R$ to $E \ge F$ characterized by (1) and (2) is called an <u>observer transformation</u> and corresponds to a change of observer from 0 to 0* It is assumed that Q (t) is suitably smooth.

[†] A more general treatment (see (6) and the comments in (4) assumes that the Euclidean point space in which events are observed, E_t , is different for each distinct instant of time t. With each <u>instantaneous</u> <u>Euclidean point space</u> E_t is associated an <u>instantaneous translation</u> space E_t . Essentially an observer transformation merely changes the description in $E \propto R$ of an event.

For future reference we note that (1) may also be written

$$\mathbf{x}^* = \mathbf{Q}(\mathbf{t}) \mathbf{x} + \mathbf{c}(\mathbf{t}) \tag{3}$$

where $c_{\sim}(t)$ is an arbitrary vector in E with x and x^* now interpreted as the position vectors in E of the points x and x^* relative to an arbitrary choice of origins in E for 0 and 0* respectively.

2.Some fields associated with the deformation and motion. As is usual in continuum mechanics, we regard a body consisting of continuously distributed material as a smooth three-dimensional manifold B say, whose points are called <u>material points</u>.

A <u>configuration</u> of B (as observed by 0) is a homeotnorphism $x : B \to E$ which takes material points to the places they occupy in \hat{E} . We identify a generic material point in B by the label X so that

where x is the place occupied by X in the configuration x It is assumed that a x nd its inverse x^{-1} have sufficient regularity for our requirements

We write $B = X(B) \equiv \{X(X) : X \in B\}$ for the region of *E* occupied by B in the configuration x. Since no confusion should arise we also refer to *B* as a configuration of B. As the body moves and deforms the region it occupies in *E* changes continuously, and a motion of B is defined as a one-parameter family of configurations $X : B \to E$ where the subscript t identifies the time as parameter.

generalizing (4), (Of course, t may be restricted to some subset of R, but this need not be specified here.)

For reference purposes, it is convenient to identify a certain fixed (but arbitrarily chosen) configuration of B so that material points are labelled during motion by their places in that configuration. Let $\underset{\sim 0}{X}$ denote such a fixed configuration and write

where x is the place of the material point X in the configuration $\underset{\sim 0}{x}$. Also set $\underset{\sim 0}{x}$ (B) = B₀. The subscript zero may, but need not, correspond to t = 0 in (5).

A fixed configuration B_0 is called a <u>reference configuration</u> and B_t the <u>current configuration</u> of the body in the motion specified by (5).

On eliminating X between (5) and (6), we obtain

where the one-parameter mapping $\underset{t}{k} : B_0 \to B_t$ thus defined specifies the <u>deformation</u> from the reference configuration B_0 to the current configuration B_t . The definition of $\underset{t}{k}$, of course, depends on the choice of reference configuration.

Thus far we have related the motion to a single observer 0. Under an observer transformation whose spatial part is written as (3) the motion (5) itself changes according to

where $x = (X^* (X, t^*))$ is the description by 0^{*} of the motion observed by 0 as (5). We remark that if Q(t) is restricted to being proper orthogonal then (8) may be interpreted as a motion recorded by 0 consisting of a rigid-body motion superposed on the motion (5). We return to this point later. In the following we examine some specific scalar, vector and tensor fields associated with the motion in order to distinguish those which depend intrinsically on 0 and those which are essentially independent of 0.

First, the velocity $\dot{X}(x,t) \equiv \partial X(x,t)/\partial t$ of the material point X transforms according to

under an observer transformation. Clearly, the velocity is directly linked to the choice of observer through the relative motion of observers implicit in $\dot{c}_{(t)}$ and $\dot{o}_{(t)}$. Similar remarks apply to the acceleration $\ddot{x}_{\alpha}(X,t)$.

In this paper it is assumed for simplicity that all observers select the same reference configuration so that the particle X is allocated the same reference point X in E by each observer. This assumpt ion affects the details but not the principle of our subsequent argument \dagger .

From (7) and (8) we see that the deformation gradient ††

where c_0 is a constant vector and Q_0 is a constant orthogonal tensor. †† Grad (with upper case G) and grad (with lower case g) denote the gradient operation relative to \underline{x} and \underline{x} respectively. the sign on the right-hand side of (12) being +(-) if Q(t) is proper (improper) orthogonal. In equation (12) and for the remainder of this Section we omit the arguments from tensors (which may be regarded as fields over either B_0 or B_t through (7)). If $Q_{\tilde{z}}$ is proper orthogonal then (1) represents a rotation of vectors in E.

It is usual to adopt the physically sensible convention that relative orientation of triads of material line elements is preserved under deformation. This means that

and this convention is preserved under an observer transformation provided Q is proper orthogonal. We adopt this convention here for all observers and therefore rule out what may be regarded as physically unrealistic deformations in which a material becomes a mirror image of itself^{\dagger}.

From (11) it follows that the right and left Cauchy-Green deformation tensors $\underset{\approx}{A}\underset{\approx}{A}^{T}$ and $\underset{\approx}{A}^{T}\underset{\approx}{A}$ satisfy $\underset{\approx}{A}^{*}\underset{\approx}{A}^{*}\underset{\approx}{A}^{T} = \underset{\approx}{Q}\underset{\approx}{A}\underset{\approx}{A}^{T}\underset{\approx}{Q}_{\sim}^{T}$, (14)

respectively. [†] This viewpoint is not accepted universally and many authors admit improper orthogonal Q_{\approx} in (3). However, new light on the problem has recently been shed by Murdoch (3) who regards the space E^* in which 0^* records events as distinct from E He assumes that the sign of det A_{\approx} is the same for all motions recorded by any given observer, allows different observers to disagree about orientation, and concludes that the implications for material response functions are independent of whether Q_{\approx} is proper or improper orthogonal, Q_{\approx} being a linear mapping from E to E* (the translation space of E*). Next, the polar decomposition

where $\underset{\approx}{\mathbb{R}}$ is proper orthogonal and $\underset{\approx}{\mathbb{U}}$ and $\underset{\approx}{\mathbb{V}}$ (the left and right stretch tensors respectively) are positive definite and symmetric.

The Green strain tensor

Under the deformation a material line element dx based on the point x in B_0 maps onto a line element dx at x in B_t according to dx = A dx. We refer to dx and dx respectively as <u>Lagrangean</u> and <u>Eulerian line elements</u>. From (3) we see that Eulerian line elements transform according to

$$d_{\tilde{x}} x^* = Q d_{\tilde{x}} x, \qquad (21)$$

while a Lagrangean line element d_x is unaffected by an observer transformation (in accordance with our assumption that all observers select the same reference configuration).

If $d_{\infty} x'$ denotes a second Lagrangean line element at X then $d_{\infty} x' = A d_{\infty} x'$ is the corresponding Eulerian line element and the strain tensors (18) and (19) are connected through

use having been made of (20) and (21). We shall comment on this shortly.

The body spin, which is a measure of the instantaneous rigid rotation of a triad of (Eulerian) line elements, is clearly influenced the rotation of observers through their relative spin $Q_{\approx \approx}^{\circ}$ Tensors by such as \mathbb{E}, \mathbb{E} and Σ are not affected in this way. These are measures extension and rate of extension of material line elements and also of the changing angles between pairs of line elements. of The scalars attached to these tensors through (22) and (25) are independent of observer and this 'observer indifference' is reflected in the transformation rules $(20)_1$ and (24).

It is important to notice the distinction between the transformation rules for <u>Eulerian tensors</u>, such as $A_{\infty}A^{T}$ and Σ_{∞} for <u>Lagrangean tensors</u> such as $A_{\infty}^{T}A_{\infty}^{T}$ and E_{∞} and for <u>two-point tensors</u> such as We A_{∞} . regard each of these tensors as <u>objective</u> in the sense that each may be associated with 'observer-indifferent' scalars as described above although the tensors themselves satisfy transformation rules of the form $(20)_1$, $(20)_2$ or (11). (Note that d x' d x = d x' (A d x).) We now justify and formalize this terminology which, at first sight, appears to conflict with the usual convention.

<u>3.</u> Eulerian and Lagrangean Objectivity. In the literature tensors are often regarded as real multilinear mappings over the translation space E, either explicitly as in (4) or, more commonly, implicitly. This means that the distinctions between Eulerian, Lagrangean and two-point tensors cannot be made clear. The difficulty can be overcome in two ways. First, by associating the reference and current configurations with distinct translation spaces, E_0 and E_t respectively, so that, for example, a (Lagrangean) vector v_{0} in E_0 is unaffected by an observer transformation while an (Eulerian) vector v transforms according to $v_{-}^* = Q(t) v_{-}$ (Recall the footnote on p.3.) The second approach is more general in that it is appropriate for tensor fields. This we now describe.

The set of Lagrangean line elements $d \ge at$ a point $\ge a$ in the reference configuration B_0 spans a (three-dimensional) vector space which we denote by $T_{\underline{X}}(B_0)$. It is called the <u>tangent space</u> of (the manifold) B_0 at $\ge a$. Similarly, $T_{\underline{X}}(B_t)$ denotes the tangent space of (the manifold) B_t at $\ge a$ and is spanned by the set of Eulerian line elements $d \ge a$

In general the tangent spaces $T_{\underline{X}}(B_0)$ and $T_{\underline{X}}(B_t)$ are distinct and they are also distinct from the translation spaces E_0 and E_t respectively (although there are isomorphisms between these spaces).

> Let $T_{\underline{x}}(B_0)^m \times T_{\underline{x}}(B_t)^n$ denote the Cartesian product $\underbrace{T_{\underline{x}}(B_0) \times ... \times T_{\underline{x}}(B_0)}_{m \text{ times}} \times \underbrace{T_{\underline{x}}(B_t) \times ... \times T_{\underline{x}}(B_t)}_{n \text{ times}},$

and L $(T \underset{\sim}{x}(B_0)^m \times T_{\underset{\sim}{x}}(B_t)^n, R)$ denote the set of real (m + n) – multilinear mappings over $T \underset{\sim}{x}(B_0)$ and $T \underset{\underset{\sim}{x}}{x}(B_t)$.

A <u>Lagrangean tensor of order n</u> at x is defined to be a member of the space $L(T_{\underline{X}}(B_0)^n, R)$. Similarly, an <u>Eulerian tensor of order n</u> at x is a member of $L(T_{\underline{X}}(B_t)^n, R)$. A <u>two-point tensor of Lagrangean order</u> <u>m and Eulerian ordern</u> is contained in $L(T_{\underline{X}}(B_0)^m \times T_{\underline{X}}(B_t)^n, R)$.

Lagrangean and Eulerian <u>vectors</u> at X and x respectively constitute the spaces $L(T_{\underline{X}}(B_0), R)$ and $L(T_{\underline{X}}(B_t), R)$. Strictly these are the <u>dual</u> <u>spaces</u> of $(T_{\underline{X}}(B_0))$ and $(T_{\underline{X}}(B_t))$ respectively, but, in order to avoid unnecessary complication, <u>we do not distinguish between vector spaces and their duals</u> <u>in this paper</u>. Note that $(T_{\underline{X}}(B_0))$ is unaffected by an observer transformation but $(T_{\underline{X}}(B_t))$ changes to $T \underset{\sim}{x} \overset{*}{} \overset{*}{}$

Let $\underline{T}(\underline{x},t) \in L(T_{\underline{X}}(B_t)^n, R)$ denote an Eulerian tensor of order n At \underline{x} The corresponding multilinear form may be written

The Eulerian tensor T(x,t) is the value at $x \in B_t$ of the tensor $\approx \sim$ Field T(.,t). defined over B_t . This is the Eulerian description of the field. But, through the motion x = k(x,t), it may be given a Lagrangean description $T_{\alpha}\{k(x,t),t\}$ corresponding to a field defined over B_0 . It remains, however, an Eulerian tensor field. Equally, through the inverse $x = k^{-1}(x,t)$ a Lagrangean tensor field may be given an Eulerian description. Thus, it is important to distinguish between a Lagrangean (respectively Eulerian) tensor field and the Lagrangean (respectively Eulerian) description of a tensor field

The situation is different in respect of scalar fields. If $\phi(\cdot,t)$ is a scalar field defined over B_t the corresponding field $\phi_0(\cdot,t)$ over B_0 is specified by $\phi_0(x,t) = \phi\{\underline{k}(x,t),t\}$ $x \in B_0$ (32) and conversely

n view of (32) and (33). We note that the scalar field det A_{\approx}^{\bullet} is objective but the particle speed $|\dot{x}(x,t)|$ is not. It follows from (34) and (29) that the components $T_{ijk}....(x,t)$ of an objective Eulerian tensor are objective scalars.

We have already noted that in standard texts such as (4) and (5) no distinction is made between Eulerian and Lagrangean fields and a field is said to be objective if it satifies the appropriate one of the (Eulerian) transformation rules (26)-(28) or (34). It then follows that Lagrangian fields such as $A^T A$ with transformation rule (31) are, by default, not regarded as objective. On the other hand. Hill (1) regards as objective only those fields for which (31) holds. The distinction we have made between Eulerian and Lagrangean fields reconciles these two views which are essentially alternative manifestations of a single definition of objectivity. We shall expand on this point in Section 4.

For two-point tensors a definition of objectivity intermediate between (26) and (30) is required. With an Eulerian description we suppose $T_{x}(x,t) \in L(T_{x}(B_{0})^{m} \times T_{x}(B_{t})^{n}, R)$.. This is an objective twopoint tensor if

It follows from (11) that the deformation gradient A(x, t) is an objective two-point tensor corresponding to m = n = 1 in (36) (but note that A(x, t) is given a Lagrangean description here).

We remark that the characterization (36) of an objective tensor field is invariant under a change of reference configuration although the fields themselves change.

In Section 2, we observed that the transformation (8) can be regarded by 0 as a rigid-body motion superposed on the motion (5). Since we are restricting attention to proper orthogonal Q(t) it is appropriate to examine the consequences of this viewpoint in relation to the definition of objectivity. According to a single observer 0 the tensor $\underline{T}(x,t)$ is objective if it is invariant under a superposed rigid-body motion (3) in the sense that $\underline{T}(\underline{x}^{*}, t)(\underline{d}^{*}\underline{x}^{(1)}, ..., \underline{d}^{*}\underline{x}^{(n)}, \underline{d}^{*}\underline{x}^{(1)}, ..., \underline{d}^{*}\underline{x}^{(n)}) = \underline{T}(\underline{x}, t)(\underline{d}^{*}\underline{x}^{(1)}, ..., \underline{d}^{*}\underline{x}^{(1)}, ..., \underline{d}^{*}\underline{x}^{(n)})$ (37) with $\underline{d}\underline{x}^{(k)}$ and $\underline{d}\underline{x}^{(\ell)^{*}}$ defined as for (36). This approach is conceptually simpler than that involving changes of observer and is entirely equivalent to it provided Q(t) is proper orthogonal. A direct correspondence between (36) and (37) is established by setting $\underline{T}^{*}(\underline{x}^{*}, t^{*}) = \underline{T}(\underline{x}^{*}, t)$ with $t^{*} = t = a$.

<u>4. Induced Objectivity</u>. We have seen in (32) and (33) that for a given motion and choice of reference configuration each Eulerian (respectively Lagrangean)scalar field is associated withauniqueLagrangean (respectively Eulerian) scalar field. Lagrangean and Eulerian vector and tensor fields mayalsobe associated through the deformation (by means of the deformation tensors A and B in particular), but not uniquely. For example, if v_{α} is an Eulerian vector field then $A_{\alpha}^{T} v$ and $B_{\alpha}^{T} v$ are Lagrangean vector fields. Respectively they are covariant and contravariant in character since

We adapt the terminology of Hill (1) and refer to $A_{\mathbb{Z}}^T v$ and $B_{\mathbb{Z}}^T v$ as (covariant and contravariant) <u>induced Lagrangean fields of v</u>. Similarly, if v is a Lagrangean vector field then and A v are $B_{\mathbb{Z}}^v v$ are <u>induced Eulerian fields of v</u>. Note that $A_{\mathbb{Z}}^T A_{\mathbb{Z}}^v v$ is Lagrangean and $A_{\mathbb{Z}}^A V$ is Eulerian. A second—order Eulerian tensor field $T_{\mathbb{Z}}^v$ has induced Lagrangean fields. $A_{\mathbb{Z}}^T T_{\mathbb{Z}}^v A_{\mathbb{Z}}^v T_{\mathbb{Z}}^v B_{\mathbb{Z}}^v T_{\mathbb{Z}}^v B_{\mathbb{Z}}^v$. From the definition (37) and a generalization of (38) it follows immediately that <u>a tensor field is objective if and only if each of its induced fields is objective</u>.

Equally, all induced tensors of $\mathring{T}_{\otimes 0}(x,t)$ are objective, but the time derivative (either at fixed x or fixed x) of an Eulerian or two—point tensor field is not objective. For example, if v is an objective Eulerian vector field then $v^* = \underset{\approx}{Q} v$, $\dot{v}^* = \underset{\approx}{Q} \dot{v} + \dot{Q} v$ and \dot{v} is therefore not objective. These are induced Eulerian fields of the time derivatives of $\underline{\mathbb{A}}^T \underline{\mathbb{T}} \underline{\mathbb{A}}$ and $\underline{\mathbb{B}}^T \underline{\mathbb{T}} \underline{\mathbb{B}}$ respectively. In the context of continuum mechanics they are often referred to as 'convected' derivatives of $\underline{\mathbb{T}}$, while in the language of differentiable manifolds (2) they are essentially Lie derivatives of $\underline{\mathbb{T}}$ with respect to the velocity $\underline{\mathbb{V}}$. The result that objective tensors have objective Lie derivatives, given in (2) is equivalent to (39) with (31). 5. Application to conjugate stress analysis. Let \mathbb{T}_{\approx} denote the Kirchhoff stress tensor (the product of the scalar det \mathbb{A}_{\approx} and the Cauchy stress tensor) and Σ the Eulerian strain-rate (both symmetric second-order Eulerian tensor fields). Then the expression $\operatorname{tr}(\mathbb{T}, \Sigma)$ represents the rate of working of the stresses on the material of the body B per unit volume of the reference configuration B_{θ} . It may be rewritten as

$$\underset{\approx}{\overset{T}{\approx}0} = \frac{\partial w}{\partial \underset{\approx}{\overset{E}{\otimes}0}}$$

Objectivity of W, and hence of T , follows automatically from that of $E_{\approx 0}$ when E is an objective Lagrangean strain tensor. This implies that W is indifferent to superposed rigid motions of the material after deformation (as is required)

Equally, W may be expressed as a function of $\underset{\approx}{F}$ but the objectivity of W is not then automatic and the restriction

$$W(\underset{\approx}{Q}\underset{\approx}{F}\underset{\approx}{Q}_{\approx}^{T}) = w(\underset{\approx}{F})$$

for all proper orthogonal $\underset{\approx}{Q}$ must be imposed. And, in general, $\partial w/\partial \underset{\approx}{F}$ is not a stress tensor. This illustrates one well-known advantage of the Lagrangean over the Eulerian viewpoint.
